AGREEMENT AMENDMENT NO. 2

WHEREAS, the County of Nueces (“County”) and Absolute Waste Services, Inc., (“Contractor”) entered into an Agreement on the effective date of March 19, 2019 for Solid Waste Collection & Disposal Service for Coastal Parks (IFB No. 3094-18); and Amendment No.1 to the Agreement on February 10, 2021 for Solid Waste Collection & Disposal Service for Coastal Parks (IFB No. 3094-18); herein “Agreement”.

WHEREAS, the parties now want to exercise the option as set out in Article II of the Agreement to extend the term of the Agreement for one year;

WHEREAS, the parties want to exercise their “second” Agreement extension and renew the term of the Agreement for twelve (12) months;

NOW, THEREFORE, Nueces County and Absolute Waste Services, Inc., in consideration of the mutual agreements contained in the original Agreement providing for a contract renewal term to do hereby mutually agree:

1. To exercise the renewal option of 12 months as set out in Article II of the Agreement extending the termination date of the Agreement to March 19, 2023 (“Amended Term”);
2. Subject to Exhibit A, to continue to apply the services and prices quoted in IFB No. 3094-18 referenced in Article I of the Agreement throughout this renewal term; and
3. All other provisions of Agreement shall remain the same.

- (A) is not organized or operated for profit and for which none of its net earnings inures to the benefit of any private shareholder or individual;
- (B) has two or more firearm entities as members; and
- (C) is exempt from federal income taxation under Section 501(a), Internal Revenue Code of 1986, as an organization described by Section 501(c) of that code.
