A cake and coffee reception will be held in the main lobby area from 6:30-7:00 pm. All are welcome to attend.

IT

- Resolved a major issue regarding our parking ramp security that was causing the system to power off unexpectedly. Several batteries needed to be replaced in the DVR system.
- The City webpage has been updated to reflect the changes on the city council, and the numbers in the phone system will be updated on January 4th.
- Plotter/Scanner research: we are looking at replacing our aging plotter/scanner setup during the first quarter this year. The current system is old and have been scheduled to be replaced this year. We are currently awaiting vendor quotes.

Parks

- Record numbers of park patrons at the warming houses for this second week of the skating season!!! So far this year the rink attendants have recorded 1,608 rink patrons using the facilities at Central and the School. This is averaging approximately 16% or 50 people per shift - up from last year at this time when the average was 42 patrons per shift. There is skatable ice at Bear Park too -- (though no one's counting there).
- Focus remains sweeping, flooding of the rinks each day to build ice depth to get us through those warm, January/February thaws later in the winter (*Ahhh, melting...*)

Planning/Building

- Meeting to discuss potential industrial building expansion on Azurite Street
- Updated forms, website, and databases with 2013 information
- Prepare updates to Land Use Application Packets-additional supplemental information typically requested by developers

Police

- **It's Working.** For the first time in several years, the Ramsey Police Department made no arrests for DUI over the New Year celebration. The police department, the County and the State of MN, have spent a great deal of time and money to get the word out about the dangers of drinking and driving. Anoka County Law Enforcement has recently put a new vehicle into service to raise awareness of drunk driving. *Attached to the Weekly Update is a Picture of the new Anoka County Law Enforcement Vehicle.*
- **Happy New Year.** Officers received a call of a 40 year old male that was DK and unable to care for himself. Upon arrival, officers were met by the male's sister who indicated that she found him passed out and naked in the basement. He submitted to a PBT with the result of .33 BAC. He was then transported to a detox center in Plymouth because he was unable to care for himself. (They helped him get dressed before the transport.)
- **More Permits.** The police department processed an additional 31 permits to purchase a handgun the final week of 2012. The total for the year was 381 permits issued compared to 276 in 2011 and 207 in 2010.

Public Works

- Continue to sand and clean up snow on a per request basis.
- Start equipment repairs that we have been putting off until the first of the year. These repairs include new rear tires on our backhoe and new tracks on the skid loader.
- On the administration side we are doing some cross training on our sign making software with the park department and starting on performance reviews.

Utilities

- Recorded all final water meter readings at all eight of Ramsey's deep wells, these numbers will be needed when we fill out the DNR water appropriations and the MET councils Sanitary survey for 2012
- Received a quote to rebuild a set of impellers for lift station #2, last summer we had a new set installed for both pumps at this site. The old set can be reconditioned this would be helpful the next time repairs must be made. The impellers at a lift station cup and pump/force the sanitary sewer from a wet well to a gravity sewer further down the line, this lift station in Riverpines subdivision pumps sewer from 158th and Neon street west to Highway 47 then south all the way to Alpine drive where it intersects with a gravity sewer

Taxi Squad



The Anoka County TZD/DWI Task Force is pleased to announce a new weapon in the ongoing campaign against drinking and driving – The Taxi Squad. The Taxi Squad’s message exhorts drivers to “Choose Your Ride,” either a taxi or other sober driver vs. a squad car following a DWI arrest. The new Taxi Squad was deployed for the first time on New Year’s Eve when it traveled throughout Anoka County, stopping at several bars, clubs, and restaurants to deliver the message to not drive after drinking. The Taxi Squad is a mobile message

platform and will not be assigned enforcement duties nor will it actually provide rides for motorists.

The Anoka County TZD/DWI Task Force includes the Anoka County Sheriff’s Office and the police departments of Anoka, Blaine, Centennial Lakes, Columbia Heights, Coon Rapids, Fridley, Lino Lakes, Ramsey, and Spring Lake Park. Getting motorists not drive while under the influence is very important to all law enforcement agencies. This project is undertaken as part of our partnership in the state’s *Toward Zero Death (TZD)* initiative. *TZD* is a multi-agency approach to address traffic issues regionally through enforcement, education, engineering and emergency trauma care.
