## ***Council Update***

**Joint Meeting with Anoka.** Some time ago, Ramsey City Council agreed to and scheduled a date for a joint meeting with the City Council of Anoka. As a reminder, that meeting is Tuesday, April 30, beginning at 5:30 p.m. The meeting will be held here in the Lake Itasca Room.

**Armstrong Interchange Senate Hearing.** Councilmember Tossey testified on behalf of the City at the Senate Transportation and Public Safety Finance Committee hearing on Monday. The bill was passed along for “possible inclusion” – a good thing.

- 4/14- Vehicle fire in the 8600 block of 171<sup>st</sup> Ave NW. Unit arrived to find vehicle fully involved. Crew extinguished
- 4/17- An 87yr old female with difficulty breathing in the 6300 block of Rivlyn Ave. Unit arrived with squad and Allina to find patient in cardiac arrest. Crew assisted with CPR until patient was loaded into ambulance. FF rode in ambulance to Mercy to assist medic


### Public Works Activities

- April continues to be a trying month for PW. The cold and snowy weather is delaying or preventing most of our normal spring time maintenance activities. The utility department continues to flush water main in between snow storms and plowing events. The park department is unable to prepare athletic fields for softball, baseball, and soccer seasons that are scheduled to begin in approximately two weeks. The street department is behind schedule on street sweeping, pothole patching and sod repair. The weather forecast looks much better for next week, so we should get back on track and move ahead quickly with spring.
