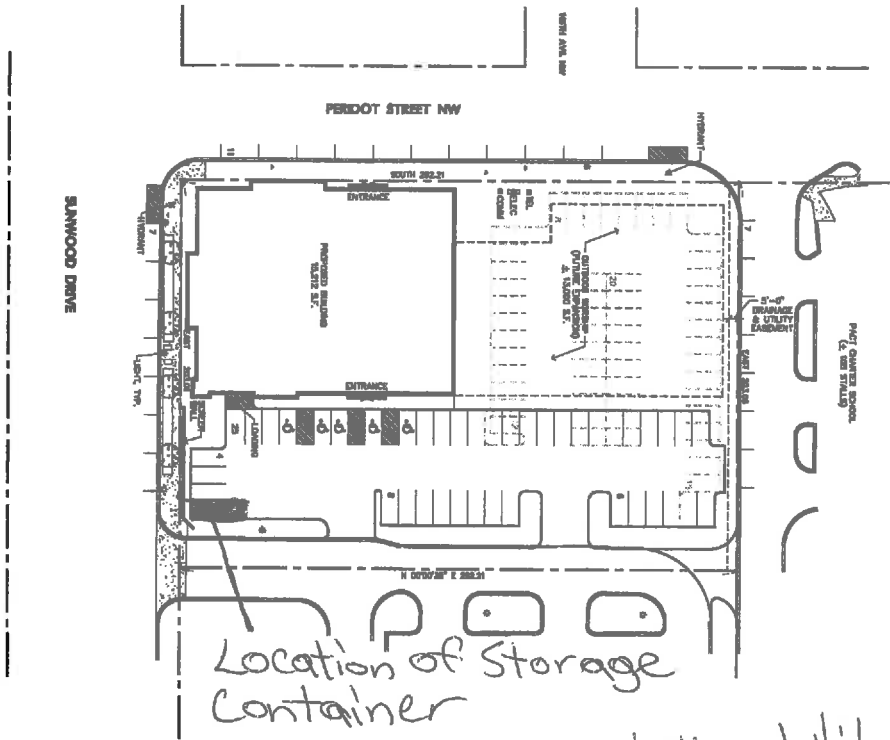


SITE PLAN
