



Such assessment is proposed to be payable in equal annual installments extending over a period of 10 years, and will bear interest at the rate of 4.60 percent per annum from the date of the adoption of the assessment resolution. To the first installment shall be added interest on the entire assessment from the date of the assessment resolution until December 31, 2018.
