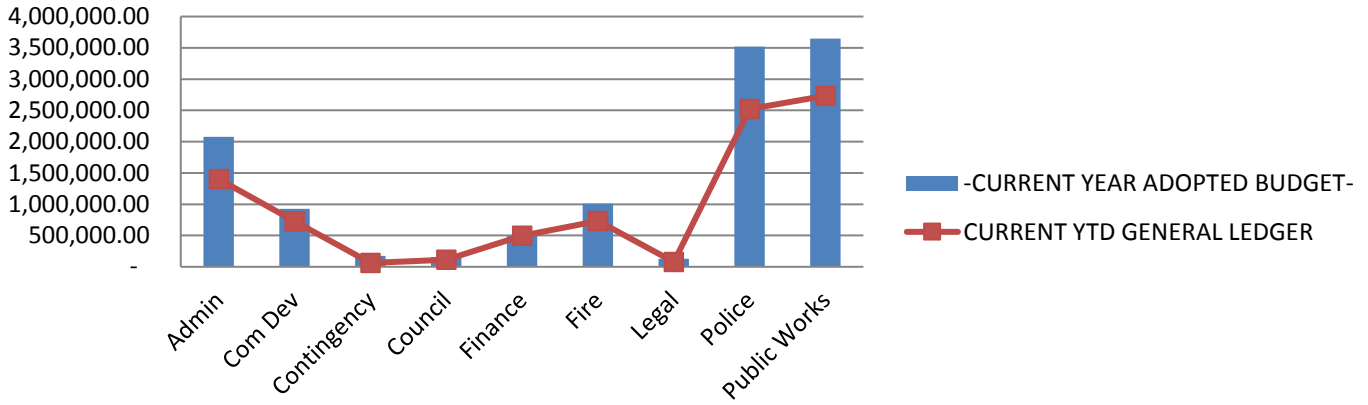

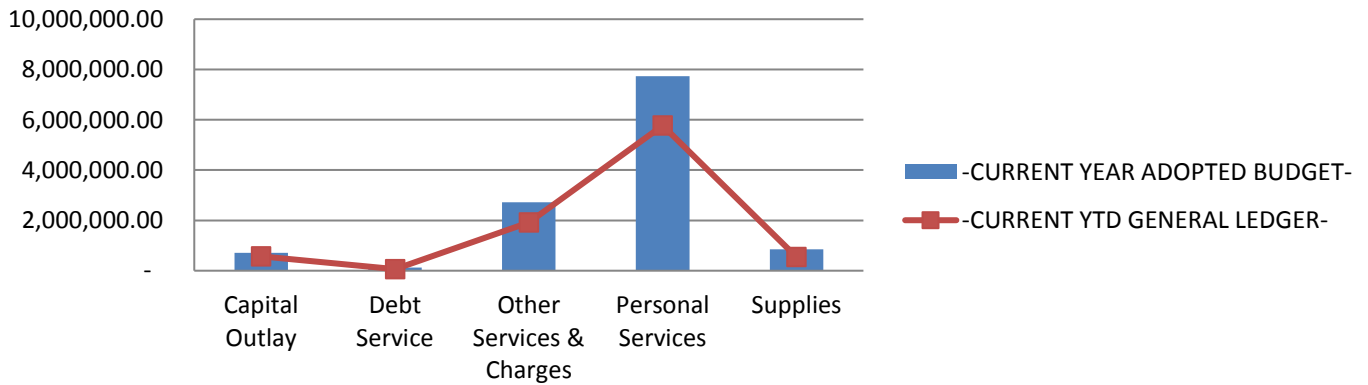

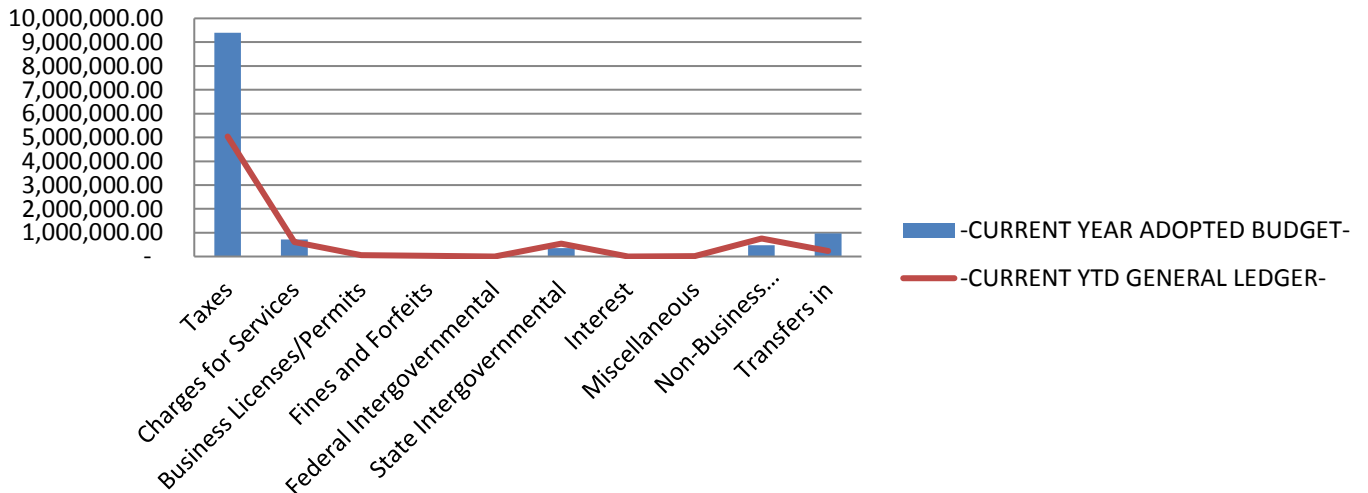
## GENERAL FUND EXPENDITURES - BY DEPARTMENT
