

Councilmember _____ introduced the following resolution and moved for its adoption:

RESOLUTION #20-214

RESOLUTION ACCEPTING QUOTES AND AWARDING CONTRACT FOR 5751 164TH LANE DRAINAGE IMPROVEMENTS, IMPROVEMENT PROJECT #19-17

WHEREAS, drainage improvements are needed to prevent stormwater runoff from leaving the public drainage ditch north of 164th Lane and flowing across the private property at 5751 164th Lane NW before discharging into the pond on the north side of said property; and

WHEREAS, the proposed drainage improvements are contained within the public right-of-way for 164th Lane, and within certain public drainage easements, and will prevent stormwater runoff from flowing across said private property; and

WHEREAS, the City Engineer prepared plans for the purpose of soliciting quotes for 5751 164th Lane Drainage Improvements, Improvement Project #19-17; and

WHEREAS, on August 18, 2020, the Public Works Committee unanimously adopted a motion to recommend City Council approval of said plans and authorization to solicit Requests for Quotes for said improvements; and

WHEREAS, pursuant to Ramsey City Council Resolution #20-176, adopted August 25, 2020, the plans prepared by the City Engineer for the making of said improvements were approved, and solicitation of Requests for Quotes for said improvements were authorized in accordance with the approved plans and specifications; and

WHEREAS, on August 26, 2020, Requests for Quotes were submitted to three contractors, and on September 10, 2020, the following quote was received from Dryden Excavating, Inc. for said improvements, and upon opening and tabulating the quote it was found to comply with the Request for Quotes; and

WHEREAS, on September 15, 2020, the Public Works Committee unanimously adopted a motion to recommend that the City Council accept the quote and award a construction contract to Dryden Excavating, Inc. for said improvements; and

WHEREAS, the quote of Dryden Excavating, Inc. of Nowthen, Minnesota, in the amount of \$22,827.78 is in accordance with the approved Request for Quotes and their quote shall be and hereby is accepted.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RAMSEY, ANOKA COUNTY, STATE OF MINNESOTA, as follows:

- 1) The Mayor and City Administrator are hereby authorized and directed to enter into a contract with said bidder for the construction of said improvements for and on behalf of the City of Ramsey.
- 2) The Mayor and City Administrator are hereby authorized and directed to accept the proposal of Bolton & Menk, Inc. to stake construction of said improvements in an amount not to exceed \$750 for and on behalf of the City of Ramsey.
