
Mr. Mayor Kuzma and Council Members for the city of Ramsey,

We are writing regarding the request for a non-traditional domesticated animal/fainter mini cross goat at the property of, 5715 150<sup>th</sup> Lane NW.

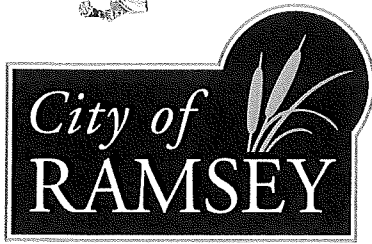
