RESOLUTION #21-139

RESOLUTION ACCEPTING BIDS AND AWARDING CONTRACT FOR TIGER STREET RECONSTRUCTION, IMPROVEMENT PROJECT #21-02

WHEREAS, the City of Ramsey proposes to reconstruct Tiger Street between Armstrong Boulevard and 173rd Avenue in 2021 as identified in the 2021-2030 Capital Improvement Program; and

WHEREAS, pursuant to Ramsey City Council resolution #20-259, adopted November 10, 2020, the City Council accepted the quotes of Bolton & Menk, Inc. to provide topographic survey services, and Chosen Valley Testing for the geotechnical evaluation services required to design and prepare plans and specifications for said improvements; and

WHEREAS, City Staff has received the topographic survey and geotechnical evaluations and has the capacity to prepare plans and specifications for improvement project #21-02, Tiger Street Reconstruction.

WHEREAS, pursuant to Ramsey City Council resolution #21-009, adopted January 12, 2021, the City Engineer has prepared plans and specifications for the purpose of advertising for bids for the same improvements.

WHEREAS, pursuant to Ramsey City Council resolution #21-085, adopted April 13, 2021, the City Council approved final plans and specifications as prepared by the City Engineer and authorized advertisement for bids for said improvements; and

WHEREAS, The City Administrator is hereby authorized to execute the proposal from Bolton & Menk, Inc. to provide construction staking services for said improvements in a total not-to-exceed amount of \$4,680 for the project; and

WHEREAS, Eleven (11) bids were received, opened, and tabulated on May 12, 2021, and the following bids were found to comply with the approved plans and specifications and advertisements for bids; and

- 2) The City Administrator is hereby authorized to execute the proposal from Bolton & Menk, Inc. to provide construction staking services for said improvements in a total not-to-exceed amount of \$4,680 for the project.
