RESOLUTION ADOPTING THE 2021, PAYABLE 2022, MUNICIPAL TAX LEVY

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RAMSEY, COUNTY OF ANOKA, STATE OF MINNESOTA, as follows:

- 1) That the following levies for assessed 2021, payable 2022, be levied upon the taxable property in said City of Ramsey, Anoka County, State of Minnesota for the following purposes:

- 2) That this final levy does not exceed the Proposed Levy adopted September 28, 2021.
- 3) That the City of Ramsey will not be levying the \$334,139 related to the \$3,090,000 GO Refunding Bond, Series 2011B, as per Joint Powers Agreement with Anoka County. Anoka County is required to pay directly to the City, this debt service amount.

- 4) That the City of Ramsey will not be levying the total \$1,142,689 (105% of debt service) related to the GO Capital Improvement Plan Refunding Bonds for the Municipal Center. The City will levy at \$788,276.
- 5) That the Finance Director be directed to transmit a certified copy of this resolution to the Anoka County Auditor's Office on or before Thursday, December 31, 2021.
