**RESOLUTION ACCEPTING PROPOSALS AND AWARDING A CONTRACT FOR TOPOGRAPHIC SURVEY FOR 2025 NEIGHBORHOOD PAVEMENT OVERLAY IMPROVEMENTS, IMPROVEMENT PROJECT #25-07 AND SUNWOOD DRIVE CONCRETE PEDESTRIAN CROSSING REPLACEMENTS, IMPROVEMENT PROJECT #25-08**

**WHEREAS**, the Sunwood Drive concrete pedestrian crossings at intersections between Zeolite Street and Rhinestone Street are proposed to be replaced in 2025; and

**WHEREAS**, pursuant to Ramsey City Council Resolution #24-282, adopted September 24, 2024, request for proposals were submitted to two (2) firms for the purpose of completing the proposed surveys; and

**WHEREAS**, request for proposals were submitted to two (2) firms for the purpose of obtaining proposals for completing a topographic survey of pedestrian ramps within the 2025 Neighborhood Pavement Overlay Improvements, Improvement Project #25-07 and Sunwood Drive Concrete Pedestrian Crossing Replacements, Improvement Project #25-08; and

**WHEREAS**, the two (2) topographic survey proposals received are tabulated below; and
