RESOLUTION ACCEPTING SEWER CLEANING & TELEVISIONING PROPOSALS FOR DICKENSON’S MISSISSIPPI ESTATE STREET RECONSTRUCTIONS, IMPROVEMENT PROJECT #25-04

WHEREAS, the City of Ramsey proposes to reconstruct the streets within the Dickenson’s Mississippi Estate subdivision; and

WHEREAS, pursuant to Ramsey City Council Resolution #24-196 adopted July 23, 2024, the Ramsey City Council accepted a proposal from Bolton & Menk, Inc. to prepare final plans and specifications for Dickenson’s Mississippi Estate Street Reconstructions, Improvement project #25-04 for the not-to-exceed amount of \$68,537.00; and

WHEREAS, pursuant to Ramsey City Council Resolution #24-302, adopted October 22, 2024, the Ramsey City Council accepted the proposal amendment from Bolton & Menk, Inc. to include additional watermain between Rivlyn Avenue and Riverdale Drive as part of the project design; and

WHEREAS, pursuant to Ramsey City Council Resolution #24-138, adopted May 28, 2024, the City Council ordered the City Engineer to request proposals for utility testing for said improvements; and

WHEREAS, request for proposals were submitted to five (5) firms for the purpose of obtaining quotes for completed the proposed cleaning and televising services; and

WHEREAS, the one (1) cleaning and televising proposal received is tabulated below; and

WHEREAS, the proposals of Hydro-Klean, LLC in the amount of \$6,456.72 for the televising of Dickenson’s Mississippi Estate Street Reconstructions, for said services in accordance with the prepared proposal is the lowest responsible quote and their quote shall be and hereby is accepted.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RAMSEY, ANOKA COUNTY, STATE OF MINNESOTA:

- 1) The Mayor and City Administrator are hereby authorized and directed to enter into a contract with Hydro-Klean, LLC for said cleaning and televising services for and on behalf of the City of Ramsey.
