RESOLUTION #25-007

RESOLUTION APPROVING FINAL PAYMENT TO PARK CONSTRUCTION COMPANY FOR 2024 MSA PAVEMENT OVERLAY IMPROVEMENTS, IMPROVEMENT PROJECT #24-06

WHEREAS, the City of Ramsey proposes to overlay the pavement on numerous Municipal State Aid (MSA) street segments in 2024 as identified within the 2024 – 2033 Capital Improvement Program; and

WHEREAS, pursuant to Ramsey City Council Resolution #23-298, adopted November 28, 2023, the City Council ordered the City Engineer to prepare plans and specifications for 2024 MSA Pavement Overlay Improvements, Improvement Project #24-06; and

WHEREAS, pursuant to Ramsey City Council Resolution #24-178, adopted July 9, 2024, the City Council approved final plans and specifications as prepared by the City Engineer and authorized advertisement for bids for said improvements; and

WHEREAS, pursuant to Ramsey City Council Resolution #24-213, adopted August 12, 2024, a contract was awarded to Park Construction Company of Minneapolis, Minnesota, in the amount of \$162,689.38 for said improvements; and

WHEREAS, as of January 14, 2025 \$163,859.29 has been paid to date; and

WHEREAS, the Senior Engineering Technician has inspected the completed work and recommends final payment to Park Construction Company of Minneapolis, Minnesota, for improvement project #24-06 2024 MSA Pavement Overlay Improvements, in the amount of \$2,949.93.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RAMSEY, ANOKA COUNTY, STATE OF MINNESOTA:

- 1) The City Council hereby authorizes final payment to Park Construction Company of Minneapolis, Minnesota for Improvement Project #24-06, 2024 MSA Pavement Overlay Improvements in the amount of \$2,949.93.
- 2) The City Council hereby accepts the project and authorizes the Mayor and City Administrator to sign the release form for this payment.
- 3) The total amount of this payment is not included in resolutions approving payment of bills for the date of January 14, 2025.
- 4) The City of Ramsey Finance Department will be provided a signed copy of this resolution.
