RE: Proposal for Construction Staking Services, City of Ramsey – Section 01 Unplatted Street Reconstructions (City Project No. 26-07)

Dear Mr. Feriancek:

We appreciate the opportunity to assist the City of Ramsey with construction staking for the above-referenced project.

SCOPE OF WORK

Bolton & Menk will complete the construction staking and as-built survey for this project, which generally includes:

- 0.20 Acres of Clearing and Grubbing,
- 75 RDST of Subgrade Bluetops,
- 75 RDST of Base Course Blue Tops,
- Removals,
- 26 Flared End Sections,
- 4 Storm Sewer Structures,
- 542 LF Storm Sewer / Culverts,
- 4 Concrete Flumes
- 50 Driveway Tie-ins,
- 1,910 LF of Concrete Curb and Gutter,
- 3,560 LF of Sediment Control Logs,
- 7,870 LF of Silt Fence,
- Salvaging 46 Mail Box Supports, and
- Miscellaneous other items.

We will also complete the As-Built Survey for Record Drawing creation.

ASSUMPTIONS

We have made the following assumptions in preparing this proposal:

- No allowance is included for staking of right-of-way.
- Replacing damaged or removed stakes is not included in our base fee.

- No additional fees for stakes, mileage, equipment, etc. will be invoiced to the City, but are included in our hourly rates.
- Additional services, if required, will be performed at the rates presented in the Proposed Fees section of this proposal.

PROPOSED FEES

Bolton & Menk proposes to perform the staking based on a not-to-exceed amount, based on the rates presented in the following table:
