**RESOLUTION APPOINTING ELECTION JUDGES FOR THE GENERAL ELECTION
ON NOVEMBER 3, 2026**

WHEREAS, the City of Ramsey will be conducting a General Election on Tuesday, November 3, 2026; and

WHEREAS, pursuant to Minnesota Statutes Section 204B.21, election judges for precincts in a municipality must be appointed by the governing body of that municipality; and

WHEREAS, the hourly rate of pay will be \$12.50 for election judge trainees, \$12.50 for regular election judges and \$14.50 for head judges; and

WHEREAS, when necessary, regular City staff working as judges on election day will be paid their normal hourly wage.

RAMSEY, ANOKA COUNTY, STATE OF MINNESOTA, as follows:**
