On 09/08/2026 at 1030 hours, I conducted a cannabis compliance check at Ramsey Tobacco Outlet. (20 years old) was assisting alongside with the compliance checks. It should be noted during the cannabis compliance checks, I was dressed in plain clothes that did not identify me as a police officer. walked into Ramsey Tobacco Outlet as I walked in only a slight delay behind her. My department BWC was recording during the compliance check.

directed the male employee behind the counter to obtain an edible cannabis product. Employee, Michael Nunez, later identified via Colorado ID provided the cannabis product for check out. Michael did not ask for any form of ID from . provided the issued \$20 bill given to her. Michael completed the sale with and she proceeded to leave the store. I followed out and obtained the cannabis product and the change of money provided to her. I went back inside the store and identified myself to Michael. Michael was cooperative and realized his mistake. Michael provided me with a receipt of the sale (\$12.31) for the "CBN Sleep and Relaxation Cannabis-Infused Gummies." I informed Michael I would be keeping the cannabis product as evidence. Michael returned me the \$20 bill given by and I provided him with his change of money back to him. Michael was issued a citation for 4th Degree Sale of Cannabis.

The cannabis gummies were entered into evidence at the police department. Photos of , her MN DL, the receipt of sale, and the \$20 bill used for the sale are entered into evidence.com.
