A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, ARIZONA APPROVING AND ADOPTING THE ARIZONA DEPARTMENT OF TRANSPORTATION FEDERAL TRANSIT ASSISTANCE DISADVANTAGED BUSINESS ENTERPRISES PROGRAM PLAN

**WHEREAS**, Arizona Department of Transportation (ADOT) has established a Disadvantaged Business Enterprise (DBE) program in accordance with regulations of the U.S. Department of Transportation, 49 CFR Part 26; and

**WHEREAS**, ADOT has received Federal financial assistance from the U.S. Department of Transportation; and

**WHEREAS**, as a condition of receipt of funding, ADOT has signed an assurance that it will comply with 49 CFR Part 6; and

**WHEREAS**, the City of San Luis is applying for a grant from said funding through ADOT called the Coordinated Mobility Program, Federal Transit Assistance (FTA) Grant Section 5310 in order to purchase vehicles to transport the elderly and disabled of all ages through the City's Senior Citizens Center programs; and

**WHEREAS**, it is the policy of the City of San Luis to ensure that Disadvantaged Business Enterprises as defined in 49 CFR Part 26 have an equal opportunity to receive and participate in U.S. Department of Transportation assisted contracts.

**NOW THEREFORE BE IT RESOLVED**, by the Mayor and Council of the City of San Luis, State of Arizona, as follows:

**Section 1:** In connection with the ADOT Coordinated Mobility Program – FTA Grant Section 5310 for the Senior Center vehicles, the City of San Luis hereby approves and adopts the Arizona Department of Transportation Federal Transit Assistance Disadvantaged Business Enterprises Program Plan also known as the ADOT FTA DBE Program Plan in substantially the form and substance attached hereto Exhibit A and incorporated herein by reference.

**Section 2:** The appropriate staff are hereby authorized and directed to cause the implementation of the ADOT FTA DBE Program Plan and to take all steps necessary to carry out the purpose and intent of this Resolution.
