EVENT PRODUCTION CONTRACT

Contract made this June 27 of 2016 between TRONIX SOUND (Johnattan Gonzalez) and CITY OF SANLUIS PARCS AND REC (hiring party). In consideration of the promises and the agreements herein contained and intending to be legally bound hereby, the Parties do agree as :

The Purchaser (hiring party) hereby engages TRONIX SOUND to provide the following services:

1. **Professional Line Array Sound System**

- A. Line Array Cabinets
- B. Subwoofers with amplifiers
- C. Active Monitors
- D. Behringer X32 Digital Mixing Console (32 channel)
- E. Microphones with cables and stands
- F. DJ / MC Services (dj music before and after performers/artists)

2. **Professional Staging**

- A. 4ft. X 8ft. Sections with adjustable height (3 ft. up to 4 1/2 ft.)
- B. 6ft. X 8ft. Sections with set height of 4 feet
- C. Set(s) of Stairs
- D. Sate Skirt

3. **Professional Lighting and Trussing**

- A. 120w LED Slim Par Cans with light controller
- B. 360w DOTZ MATRIX LED LIGHTS with light controller
- C. 70w LED Moving Heads with controller
- D. 10ft. Sections of Trussing
- E. 6ft. Sections of Trussing

In order to secure the mentioned date, a deposit of 50% of the total(\$ 2,250) is due at the signing of this contract.

Balance of \$ 2,250 due in CASH (or check if agreed upon by both parties) least 1(one) business day before the start of event on the date of engagement. The deposit is non-refundable and not transferable to another location or for times other than those stated here on this contract. The deposit is paid for the sole purpose of reserving the agreed times, date and location only.

If Purchaser(hiring party) will make final payments by check, it is to be made out to TRONIX SOUND and shall be paid at least 1(one) week before the event starts.

Services requested that exceed the time frame will be charged at the rate of \$1,000 dollars per hour, payable the day of the engagement. It may not always be possible to provide additional performance time. However, when feasible, requests for extended playing time will be accommodated.

Purchaser (hiring party) shall make available to TRONIX SOUND:

- A. The place of performance at least 1(one) day prior to scheduled performance time or the sole purpose of setting up.

Additional Terms and Conditions:

A. It is hereby further agreed; that the Purchaser(hiring party) shall be held liable for any damages to the property of TRONIX SOUND, while on the premises of said engagement.

B. If damage is caused by Purchaser(hiring party) or their guest, member of his organization, engagement invitees, or any other party in attendance, whether invited or not, THE PURCHASER(hiring party) IS RESPONSIBLE FOR REPLACING THE DAMAGED EQUIPMENT WITH ONE OF EQUAL OR BETTER VALUE WITHIN 3 BUSINESS DAYS OF THE EVENTS END.

C. It is understood that if this is a "Rain or Shine" event, TRONIX SOUND's compensation is in no way affected by inclement weather.

D. For outdoor performances, Purchaser(hiring party) shall provide overhead shelter for setup area.

E. TRONIX SOUND reserves the right, in good faith, to stop or cancel the event should the weather pose a potential danger to him, the equipment, or audience.

F. Every effort will be made to continue the performance. However, safety is paramount in all decisions. TRONIX SOUND's compensation will not be affected by such cancellation.

G. Purchaser(hiring party) shall provide TRONIX SOUND safe and appropriate working conditions.

H. TONIX SOUND will be set and ready to go at least 1 hour before your event starts.


