3. DISCUSSION AND POSSIBLE ACTION ITEM(S):

3.A. Discussion and possible action on any and all matters regarding settlement of all pending litigation and claims. Discussions to include but not limited to:

- **litigation regarding United States District Court for the District of Arizona case, San Luis Facility Development Corporation v. CEC and CiviGenics No. CV14002633 PHX DMF,**
- **litigation regarding Arizona Superior Court for Yuma County case, San Luis Facility Development Corporation v. CEC and CiviGenics Case No. S1400CV2010-586,**

- **litigation regarding Arizona Superior Court for Yuma County case, Houston Casualty Company v. CEC, Emerald, SLFDC Case No. S1400 CV 2016-00456. (Kay Marion Macuil, City Attorney)**

Ms. Kay Macuil, City Attorney, explained that the City of San Luis received a final settlement on these three (3) cases, there has been no impact to the City's treasury during this litigation, however she recommended approval of this final settlement. It releases everybody, every direction and gives relief to the City's operator to keep the doors open and employment for their current employees.

Mayor Gerardo Sanchez asked if this is a public record. Ms. Macuil responded that this is a public record and can be discussed openly.
