**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA AUTHORIZING A TEMPORARY REDUCTION IN CERTAIN FEES UNDER RESOLUTION NO. 770 PARKS AND RECREATION FEE SCHEDULE.**

**WHEREAS**, the Mayor and City Council of the City of San Luis desire to encourage recreation and physical fitness of the residents of the City of San Luis; and

**WHEREAS**, sports leagues are in need of some temporary financial relief in order to adjust to the full implementation of the fee schedule in Resolution No. 770 to continue their activities in the City of San Luis playing field facilities;

**WHEREAS**, Resolution No. 770 and its attached fee schedule are provided here as Exhibit "1" and the fees which are the subject of this resolution are highlighted in yellow.

**THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of San Luis, Arizona, as follows:

**Section 1.** Until further direction of the Mayor and City Council of the City of San Luis, the City Manager as recommended by the Director of Parks and Recreation is hereby authorized and in the City Manager's discretion to reduce up to a maximum of fifty percent (50%) of those Athletic Parks and Recreation Facility Fees under Resolution No. 770 pursuant to the following criteria:

1. The fees are under the fee schedule for Class-B Nonprofit which are individuals, groups, or organizations using facilities whose purpose is clearly of nonprofit nature (501 C Status) or social gathering. (Receptions, religious groups, etc.); and
2. The fees are under the fee schedule for Residents of the City of San Luis, Arizona; and
3. The fees eligible for reduction shall be confined to the fees for
  - a. lining fields (a per field fee of \$10.00 under Resolution 770) and
  - b. lights (a per hour and per field fee of \$10.00 under Resolution 770).

**Section 2.** Those requesting a reduction in fees under this Resolution must provide to the Director of Parks and Recreation or to a designee chosen by the City Manager the following:

1. A certification of the non-profit status and purpose of the applicant and that all participants reside with the City of San Luis, Arizona;
2. The number of participants and the participants' home addresses;
3. Such financial information as may be necessary for the City to determine what fees the applicant has charged to the participants, what fees the applicant collected, revenues and expenses of the applicant for providing recreational services including bank statements and other records;

**Section 3.** Failure of the applicant to provide any of the required information or if the City Manager determines that the certification was false shall result in a revocation of the fee reduction and all fees shall be immediately due in full.

**Section 4.** The City Manager or designee of the City Manager are hereby authorized and directed to take any and all actions as may be necessary to put this resolution into effect.
