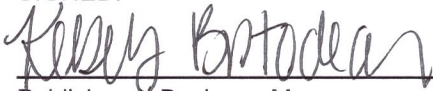

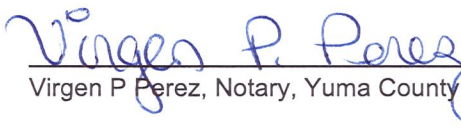

(M.S.T.) on Thursday, January 25, 2018 for furnishing all labor, materials, equipment, tools and performing all services required for the construction of the **San Luis Price Center – Roofing Replacement Project**, and work incidental thereto. Proposals will then be publicly opened and read aloud. The proposed work is located within the limits of the City of San Luis, Arizona.
