7. SUMMARY OF CURRENT EVENTS

Mayor Gerardo Sanchez informed that he met with Congressman Paul Gosar from District #4. This meeting was regarding the support of San Luis Port of Entry I, as the city is not willing to lose \$248.3 million dollars for this project. He stated that staff requested full support of the Arizona delegation on this project. He thanked Vice Mayor Maria Cecilia Cruz, Council Member Matias Rosales, City Manager Tadeo A. De La Hoya and Public Information Officer Francia Alonso for their support. Furthermore, he informed that he would be traveling to Tucson for a meeting with other state representatives regarding this same matter. Mayor Gerardo Sanchez also informed that the other issue discussed was the changing of the zip code in the city. He mentioned that this happened overnight and approximately 36,000 individuals were affected by the change of zip code and the United States Postal Service (USPS) did not notify those individuals. He informed that San Luis, Arizona is the second biggest city in the nation with the most post office boxes. He stated that he asked Congressman Paul Gosar for his help as he is the Vice-Chairman of the Oversight Committee that oversees USPS. He mentioned that the residents expect clarification from the USPS that will educate the residents. Mayor Gerardo Sanchez stated that once updates are ready, he will bring them before City Council and staff. He thanked council members and staff that attended the League of Arizona Cities and Towns Annual Conference for making San Luis shine during this event.

Vice-Mayor Maria Cecilia Cruz informed that she and other council members and city staff attended the League of Arizona Cities and Towns Annual Conference. She mentioned that the San Luis Port of Entry I was also discussed during one of the meetings. She thanked the Gadsden Mariachi Band for their performance during this event. She also thanked staff for the work done during this event. She added that during the Parade of Flags the city had a representative from the City of San Luis Youth Council.

Council Member Jose Ponce agreed with Vice-Mayor Maria Cecilia Cruz and added that the Mariachi was great and it brought the attention from attendees during this event.


