A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, YUMA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE SPECIAL ELECTION HELD ON MAY 21, 2019, IN THE CITY OF SAN LUIS, ARIZONA.

WHEREAS, the City of San Luis, Yuma County, Arizona did hold a Special Election on the 21st day of May, 2019, for the election of the question of the proposed primary (ad valorem) property tax implementation;

WHEREAS, the 2019 Special Election returns have been presented to and have been canvassed by the City Council;

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the City of San Luis, Yuma County, Arizona, that the canvass and return for the Special Election of May 21, 2019 be as follows:

Section 4: That the number of spoiled ballots by precinct at said special election, as shown by the final results as reported by Yuma County, are set forth on the reports, attached and incorporated into this resolution.
