WHEREAS, the City of San Luis, Yuma County, Arizona did hold a Primary Election on the 4th day of August, 2020, for the election of three (3) Council Member seats;

WHEREAS, the 2020 Primary Election returns have been presented to and have been canvassed by the City Council;
