A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, YUMA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE GENERAL ELECTION HELD ON NOVEMBER 3, 2020, IN THE CITY OF SAN LUIS, ARIZONA.

WHEREAS, the City of San Luis, Yuma County, Arizona did hold a General Election on the 3rd day of November, 2020, for the purpose of a question on whether to ratify the City of San Luis 2040 General Plan;

WHEREAS, the 2020 General Election returns have been presented to and have been canvassed by the City Council;

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the City of San Luis, Yuma County, Arizona, that the canvass and return for the General Election of November 3, 2020 be as follows:

Section 1: That the total number of ballots cast and total voter turnout at said general election, as shown by the final results as reported by Yuma County, are set forth on the reports, attached and incorporated into this resolution.

Section 2: That the number of votes cast at each precinct at said general election, as shown by the final results as reported by Yuma County, are set forth on the reports, attached and incorporated into this resolution.

Section 3: That the number of rejected ballots by precinct at said general election, as shown by the final results as reported by Yuma County, are set forth on the reports, attached and incorporated into this resolution.

Section 4: That the number of spoiled ballots by precinct at said general election, as shown by the final results as reported by Yuma County, are set forth on the reports, attached and incorporated into this resolution.

Section 5: That the votes cast for the question on whether to ratify the City of San Luis 2040 General Plan were as follows:
