Mr. Glenn Gimbut, Assistant City Attorney, said that the purpose of this resolution is to declare the fire code a public record, three (3) copies are filed with the City Clerk, so it can be adopted as a public record which avoids staff a high cost in publication fees. **5.E. Discussion and possible action on any and all matters regarding Ordinance No. 405. An ordinance of the Mayor and City Council of The City of San Luis, Arizona, amending the San Luis City Code, Chapter 150 Building Regulations to adopt the NFPA 1, Fire Code 2018 and the City of San Luis Amendments to the NFPA 1, Fire Code 2018; repealing Section 150.008.1 in its entirety and renumbering sections 150.008.2 through 150.008.4 to conform thereto; amending Section 150.999 Penalty; repealing any conflicting provisions; and providing for severability. (ITEM CONTINUED FROM SPECIAL COUNCIL MEETING HELD DECEMBER 22, 2020.) (Angel Ramirez, Fire Chief and Ric Bauerman, Fire Inspector; Glenn Gimbut, Assistant City Attorney)**

Mr. Glenn Gimbut, Assistant City Attorney, explained that the City Council had some questions about how this code would apply to existing buildings to include older buildings and sprinklers. There are grandfathered provisions in this code, but they operate a little differently than the zoning code. The grandfathered provisions of this code state specifically that unless otherwise specified by sections 1.3 to 4.1 to 113243...the current provisions of the current standards shall not apply to facilities, equipment structures, or installations that existed or were approved for construction before the effective date of this code. With respect to sprinklers, when a building changes occupancy, which would tripwire the sprinkler provisions. This code allows, like all building codes, they are goal-related, and there are provisions that allow the Fire Prevention Division to be able to accept alternatives that achieve safety.

Mr. Rick Bauermann, Fire Inspector, stated that to retrofit on any existing building is double the cost of a brand new building with sprinklers, and the Fire Department/Fire Prevention Division realizes that and works with the community to make adjustments to the building to become more compliant, that may be asking perhaps for wireless smoke detectors with an alarm system.

Mr. Angel Ramirez, Fire Chief, added that they are there to provide safety for the Fire Department/Fire Prevention Division, but they also work with its community. The Fire Department/Fire Prevention Division is not trying to hinder the community from trying to expand or trying to fulfill a dream.

Vice Mayor Matias Rosales said that his two (2) concerns are those buildings that fall below 500 square feet when other cities are doing 1,000 square feet. He wishes that staff would go to 1,000 square feet. Now the city counts with staff that understands and accept alternatives, but what about when there is a change of staff, and they do not understand that...he wanted to make sure all this is in writing. He asked if staff confirmed the size of the building if 500 square feet or 1,000 square feet would be the norm, especially for older downtowns.

Mr. Bauermann responded that the older downtown area is all mercantile, so there normally is not a change of occupancy, therefore that would not justify anything. The only time that it may justify it is they have somebody comes in with hazardous materials.

**5.G. Discussion and possible action regarding Ordinance No. 407. An Ordinance of the Mayor and City Council of the City of San Luis Arizona Amending the City Code Section 112.99 establishing a minimum fine in the “Border Area” for conducting taxicab business on public property not designated as a border area taxi stand or border area waiting stand.; repealing any conflicting provisions; providing for severability; and imposing a penalty (Kay Marion Macuil, City Attorney)**

Council Member Mario Buchanan Jr. declared a possible conflict of interest on items 5.G., 5.H., and 5.I. and abstained from voting.

Ms. Kay Marion Macuil, City Attorney, informed that this item was discussed during the January 6, 2021, Work Session. She mentioned that this ordinance is for a parking fine in the amount of a minimum of \$250 for taxi companies parked in public parking.

Vice-Mayor Matias Rosales asked Ms. Macuil if a person calls for taxi service and requests to be pick up in private property, will this be considered a violation of Ordinance No. 407.

Ms. Macuil replied that the city does not control private properties and taxis can pick up people on private property, the problem would be to pick up a passenger in public parking.

Mr. Richard Jessup, Chief of Police, explained that picking up pedestrians on the road is currently not the problem; he mentioned that currently, the problem is that taxi cabs were set up at the parking meters on Urtuzuastegui Street between Main and William Brooks Streets. He mentioned that this ordinance would apply when those taxi cabs are set up doing business on any parking meter or curb.

This ordinance will allow the Police Department to enforce the minimum fine. He mentioned that the city removed the five (5) public parking meters and moved the loading and unloading site.

**6. SUMMARY OF CURRENT EVENTS**

Mayor Gerardo Sanchez informed that the city started a vaccination campaign against COVID-19, the Yuma County started vaccinating for COVID-19, but San Luis and Somerton residents are not being seen, as there is a registration process to make an appointment. He mentioned that the city would help the community schedule their appointments to vaccinate as many community members as possible. He asked each Council Member to join this campaign as every resident must get vaccinated. He added that this would be a non-stop campaign where volunteers will be needed.

Council Member Luis E. Cabrera commented that San Luis residents had approached him to find out if it is possible to get the vaccine in San Luis. He mentioned that Walmart would be administering the vaccines, but currently, there is no set date.

Mayor Gerardo Sanchez replied that he is currently working on that matter with the State of Arizona and the Yuma Regional Medical Center and utilized the Fernando Padilla to provide that service.

Council Member Africa Luna-Carrasco thanked Mayor Gerardo Sanchez for doing this for the community.

Council Member Jose Ponce asked Mayor Gerardo Sanchez if the COVID-19 testing will continue to be provided to the community.

Mayor Gerardo Sanchez replied that testing would continue and mentioned that San Luis needs rapid testing, from which he will advocate for that type of testing.

Council Member Luis E. Cabrera informed that he addresses school closures and funding while listening to the State of the State Address from the Arizona governor. He mentioned that teachers are upset because of what was said and all agree that all schools shall remain hybrid.

Mayor Gerardo Sanchez commented that he has met with Kay Marion Macuil, City Attorney. He mentioned that city, with the backup of local officials and schools, will challenge this decision, as this is not fair for the community.

Council Member Jose Ponce informed that the VITA program would soon start helping the community to file their income taxes for free.

Council Member Africa Luna-Carrasco informed that she attended the Yuma County Board of Trustees meeting. She mentioned that they are currently planning the 100<sup>th</sup> anniversary.

Mr. Tadeo A. De La Hoya, City Administrator, mentioned that as the city has started campaigning on the COVID-19 vaccines, he would like to ask residents not to wait until their employees start vaccinating. Everyone is invited to schedule their appointments online through the Yuma County Health Department portal.

Vice-Mayor Matias Rosales thanked staff for the continued support of the #MaskUpSanLuis, for going international, and requesting support from San Luis Rio Colorado, Sonora, Mexico.
