**AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA AMENDING THE SAN LUIS CITY CODE SECTION 152.225 REGARDING MEDICAL MARIJUANA AND MARIJUANA ESTABLISHMENT USES BY AMENDING SUBSECTIONS 152.225(G) AND 152.225(H); REPEALING ANY CONFLICTING PROVISIONS; AND PROVIDING FOR SEVERABILITY;**

**WHEREAS**, the City of San Luis ("City") seeks to protect public health, safety, and welfare by enacting reasonable regulations;

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of San Luis, Arizona, as follows:

**Section 1.** Subsections 152.225(G) and 152.225(H) of the City Code regarding medical marijuana and marijuana establishment uses are hereby amended to read as follows:

(G) Marijuana establishments and dual licensees who operate both a nonprofit medical marijuana dispensary and marijuana establishment cooperatively in a shared location shall comply with all of the provisions of §§152.225 (A) through (F) and such provisions shall specifically apply to marijuana establishments and/or dual licensees as they do to medical marijuana dispensaries.

(H) Any cultivation by a marijuana establishment shall be in compliance with §§152.225(D) and (E). Any cultivation not associated with a marijuana establishment or with a medical marijuana dispensary is prohibited, and only one offsite cultivation location shall be permitted for each medical marijuana dispensary or marijuana establishment with which it is associated.

**Section 2.** Providing for Repeal of Conflicting Ordinances.

All ordinances and parts of ordinances in conflict with the provisions of this ordinance or any part of the Code adopted herein by reference are hereby repealed.

**Section 3.** Providing for Severability.

If any section, subsection, sentence, clause, phrase or portion of this ordinance or any part of the Code adopted herein by reference, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.
