## **6. DISCUSSION AND POSSIBLE ACTION ITEMS:**

**6. A. Discussion and possible action on any and all matters regarding the ratification of payment to Wizard Education. (Angel Ramirez, Fire Chief)**

Mr. Angel Ramirez, Fire Chief, indicated that Wizard Education has been the vendor utilized for their educational needs. The paramedic class began in May with the intention of paying for it in the new fiscal year in the amount of \$16,900.00, he also asked that the formal purchasing procedures be waived as permitted under the Purchasing Code. He concluded with Wizard Education has a 93% passing rate on the first time they take a test, they are one of the highest in the state and they are also Interactive Network (ITN).

**6. B. Discussion and possible action on any and all matters regarding the salary adjustment budget for Fiscal Year 2021 - 2022. (Monica Castro, Director of Finance)**

Ms. Monica Castro, Director of Finance, explained that in this year's budget, staff included \$666,240.00 to complete the third (3<sup>rd</sup>) phase of the salary adjustment for city employees. After reviewing to ensure consistency, the fiscal impact increased to \$866,240.00 which is \$200,000.00 more than budgeted. Last year, there was no salary adjustment due to COVID-19, therefore staff considers that this year it is very important that it is done. The implementation of this phase if it happens, will bring all city employees in general Fire and Police Departments to 100% of their salary target and at least to 95% in the executive and management classes. The proposed effective date is August 28, 2021. She added that there is budget capacity to make this possible in the Capital Projects Account. The ladder truck for the Fire Department will be ordered this year, however it will not be here until next year, therefore this relieves some budget capacity. Staff is asking the Mayor and City Council for authorization to transfer \$200,000.00 from the Capital Projects Account to the various salary accounts.

## **7. SUMMARY OF CURRENT EVENTS**

Mayor Gerardo Sanchez, reported he met the new Mayor Elect for Rocky Point and discussed his agenda and the projects he has been working on. Mayor Gerardo Sanchez thanked the Mayors from the Cities of Yuma and Somerton and the City Manager from the Town of Wellton for being there.

It makes an impact when they gather together and improve their relationships. He added that they will continue working together to reinforce the region to improve the economies on both sides.

Mr. Lizandro Galaviz, Director of Parks & Recreation, reported that his department is working and planning the city's Founders Day, which is scheduled for October 2, 2021. He added that usually the week before, the Founder's Day Parade takes place, however staff will postpone it this year. Staff met with the Gadsden School District Superintendent and they are concerned with the rise of the different cases, they had an increase of students with the online learning alternative. The school district, the Senior Center and other groups are a big part of the parade and it would not be a parade without them.

Vice Mayor Africa Luna-Carrasco, reported that last Wednesday, she attended the redistricting hearing that was held in Yuma after ten (10) years, the commission is looking at the redistricting. A hearing was held and there was good participation, several people spoke up for South County. She also attended the Library Board of Trustees and the San Luis Branch is planning their Hispanic Heritage Month from September 15 – October 15. They are looking for members of the community that are artistically inclined. She also mentioned that Mayor Gerardo Sanchez and herself attended the internship presentations and was impressive to see the interns speak publicly.

Mayor Gerardo Sanchez added that he is very proud the interns, there was one (1) from Somerton and the rest were residents of San Luis. The City of San Luis is trying hard to recruit to improve the number of interns to participate. Early next year, the city is going to have the businesses involved so that interns also have that experience. He also attended the graduation ceremony for the cadets who passed their academy. He thanked the San Luis Police Department for the support they provide to the cadets.

Council Member Matias Rosales, reported that he attended the Yuma Metropolitan Planning Organization (YMPO) ribbon cutting ceremony the Highway 95 Expansion Project on Avenue 9E and Highway 95. Hopefully in the near future, he will see the Cesar Chavez expansion ceremony.

## **8. CALL TO THE PUBLIC**

Maria Cecilia Cruz, 1255 Ruiz Avenue, San Luis, AZ, said they wanted to express their anger because of last Wednesday. She asked why did Council Members Jose Ponce, Luis Cabrera and Gloria Torres went out the back the door when they had asked them to step into the lobby and talk to the residents. She added that those are the Council Members' voters, it is disrespectful and shows their true character. She asked if this is revenge, she asked Council Member Gloria Torres if she was ending Tadeo's contract to get revenge because there is no reason. She remembers Council Member Gloria Torres telling her that a former Mayor let go of her daughter and that former Mayor was Council Member Gloria Torres's friend at that time. She added that Tadeo's mom was her friend and both would travel together and attend events together.

Ms. Cruz mentioned that in her eight (8) years as Council Member, Tadeo has been very professional; doing his job as Interim Administrator and as Administrator with excellence. She addressed Vice Mayor Africa Luna-Carrasco that she would call Tadeo friend; that she has a reputation of doing this to her friends and asked if this is going to be their legacies; getting rid of Tadeo because of revenge. There is no reason to get rid of Tadeo and if there were concerns they should have mentioned it to him face to face. As Council Member's trying to end a friend's contract...she asked what has the City Council done in the years they have served the city; something that residents can see and would want to vote for them again. The City Council approved the community park but there are two (2) Council Members who did not but yet they were quick to take a picture in front of the sign. She continued by saying that the City Council needs to think about it because residents are sick and tired of them not doing nothing for the community. Ms. Cruz indicated that she was given a letter from a resident that was not able to attend the meeting in person and asked for permission to read it.

Ms. Maria Cruz read a letter from resident Gloria Reyes, 1655 C Street, San Luis, AZ, the letter stated she supports to return Mr. Tadeo Azael De La Hoya to his position. That she is against the decision taken by the Council Members Jose Ponce, Luis Cabrera, Gloria Torres and Africa Luna-Carrasco. Ms. Cruz provided the letter to Mrs. Sonia Cornelio, City Clerk.

Ms. Maria Robles, 1195 California Street, San Luis, AZ, stated she was there for the same reason she was at the meeting two (2) weeks ago to ask for unification for the immigration reform campaign so that farm workers are included. The DREAMers have the support of organizations as well as those for Temporary Protected Status (TPS), but unfortunately farm workers do not have any representation from Arizona. She has tried to meet with Council Member Luis Cabrera to discuss the subject. This Friday her group will begin to gather throughout the city to collect the 5,000 signed cards needed by March 31, 2021 to take them to Senator Kyrsten Sinema's Office, who is their voice in Washington, D.C. She asked for the support from the City Council for their people.

Mr. Gilbert Zarate, resident, said that those who took a decision two (2) weeks ago, to check what they are doing, because he thinks that this person that was just let go had done a good job. He is a humble and honest person and has represented each one of the Council Members when they are not present. He asked that they amend their decision, because just how they let go of this person, the day of tomorrow some Council Members will have to go to elections. He added that if things are not right, he will be the first one that will vote against those four (4) and he will win as he already did it once with a person the City Council knows and he/she lost the election. Once again he asked the City Council to amend their decision because the community is outside asking that they think twice about their decision. This person also has a family like the City Council Members and himself and lives from his work. He has a commitment with the Mayor, City Council Members and the residents, he asked what was the reason to let him go. If he committed an error, he should have been informed, but to take a decision without fundamentals, is a mistake that will cost the city and its residents. He ended by requesting they think it well or else he will be after them during the elections.

Mr. Gary Snyder, Resident, mentioned that there is a senator that is not in this district but he has been accused of sexually assaulting kids. The bills that have been signed by Lisa Otondo and Charlene Fernandez, is something that is part of the community in south county that the community does not condone. Recently, this community also learned about the band teacher touching kids in the Gadsden School District and that should not be condoned. On top of this, there is a lot of bashing going on, on homophobia adding that he does not know if this an issue for maybe trying to kick out Tadeo. There are no reasons from Council Members Jose Ponce, Luis Cabrera, Gloria Torres and everyone else who voted yes to get him out. Mr. Snyder said they would like to know why; now if he just has not done the job, he will accept, probably the residents will not, but at least they will understand. But if there is no explanation as to why, all he sees there is what the normal name is. To him San Luis, Arizona is the worst city in this state that has corruption, nepotism, which the community already knows. City Council Members are not showing it to say that is not true, that they got elected and earned their spot and actually be good board members and Mayor as well. What he wants to know and the public is what did Tadeo do to deserve a vote of not being appointed. He asked if they are going to put in possibly her daughter or Monica who is her goddaughter as well. Who else do they have that has the experience or maybe the possibility of being a better City Administrator. It took them two (2) weeks to say at least when they asked at the last board meeting, how much time do they need, which was two (2) weeks to find them. So that means they already knew how they were going to vote, so that was against the open meeting law. Because they met about a vote that had not happened yet and already knew who they were going to appoint. The community wants to know what did Tadeo do and the facts mentioned are pertinent for the residents, for them to understand and trust them as board members, the residents need the information. He recommended that the City Council tells the truth.

Mayor Gerardo Sanchez indicated he placed this item on the agenda as a possible option, he wants to make sure they all understand the decision they are about to make and he feels that Mr. De La Hoya should have an opportunity to continue. He believes Mr. De La Hoya is not perfect but all can do better. He wants to make sure that each individually Council Member has the option to think about it.

Council Member Matias Rosales commented he has had the privilege of working for the community and Mr. De La Hoya for ten (10) years. He also does not agree that there is a valid reason for this type of change; especially at this time during the city's growth and with the large projects they have started such as the Port of Entry. They also have expansion, remodel, street projects and everything else going on. The city is coming up in the eve of an election year next year, which will affect the recruitment a new City Manager. Everyone knows that the City Manager's position is about an average of two and half (2 ½ ) years, so to find someone to replace an existing City Manager right now is going to be tough. But again, he does not see no reason for the change.


