A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SAN LUIS, YUMA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON AUGUST 2, 2022.

WHEREAS, the City of San Luis, Yuma County, Arizona held a Primary Election on the 2nd day of August 2022, for the election or nominations of a Mayor and three (3) Council Members: and

WHEREAS, the 2022 Primary Election returns have been presented to and have been canvassed by the City Council pursuant to Arizona Revised Statutes §§ 16-642 and 16-646; and

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the City of San Luis, Yuma County, Arizona, declare the results of the Primary Election of August 2, 2022, as follows:

Section 1: That the total number of ballots cast at said primary election, as reported by the County, was 2,785 and is set forth on the reports, attached and incorporated into this resolution.

Section 2: That the number of ballots cast in each precinct at said primary election, as shown by the final results as reported by Yuma County, are set forth on the reports, attached and incorporated into this resolution.

Section 3: That the number of ballots rejected in each precinct at said primary election, as shown by the final results as reported by Yuma County, are set forth on the reports, attached and incorporated into this resolution.
