7. DISCUSSION AND POSSIBLE ACTION ITEMS:

7. A. Discussion and possible action on any and all matters regarding Ordinance No. 437. An Ordinance of the Mayor and City Council of the City of San Luis, Arizona repealing San Luis City Code Section 5.15.090 border area taxi vehicle permit and regulations; and providing for severability. (Glenn Gimbut, Assistant City Attorney)

Mr. Glenn Gimbut, Assistant City Attorney, explained that a couple of years ago, the city adopted a set of ordinance dealing with regulating the use of the taxi stand at the Port of Entry. A system was set up for special permits limiting those permits to 35 to use the four (4) parking places that are at the border. He added that Mayor Nieves Riedel has requested that to be set aside, as she believes very strongly that it should be open to all taxis who do business in the City of San Luis. This ordinance repeals one (1) section of the code, which sets up the entire system for special permits and by repealing this, the program is being set aside and would open all four (4) spaces to all taxis doing business in the city.

Vice Mayor Luis E. Cabrera asked if this ordinance is approved tonight does the temporary taxi stand stay where it is at.

Mr. Ralph Velez, Interim City Manager, indicated that the taxi stand between Main Street and William Brooks Avenue stays. He further stated, there are issue with the Fire Department on the one located between William Brooks Street and Second Avenue.

Mr. Angel Ramirez, Fire Chief, stated that a few years ago, he made a point that the taxi stand on the north side between William Brooks Avenue and 2nd Avenue should not be used because when taxis parked on the north side it made the Fire Department's units go into oncoming traffic and makes it hard for them to go into the Port of Entry, therefore this area does not work for the Fire Department's units. As to the one located on Main Street to Williams Brook Avenue, they do not have an issue.

There was some discussion amongst City Council and Chief Ramirez regarding the temporary taxi stand, Fire Department's operations, taxi cab services and the construction of the new Port of Entry.

Mayor Nieves Riedel commented she asked the ordinance to be repealed so that everyone can have the same opportunity. The City Council should not be regulating and telling people who is welcome to come and who is not to the city, everybody should be treated the same way with the same opportunity.

Vice Mayor Luis E. Cabrera stated that if the ordinance is repealed, taxis need to still respect the city's rules for traffic and the Police Department.

7. B. Discussion and possible action on any and all matters regarding an employment contract for a City Magistrate. (Ralph Velez, Interim City Manager)

Ms. Kay Macuil, City Attorney, explained this is the employment agreement for the Justice of the Peace Judge Guerrero as Magistrate.

Council Member Gloria Torres commented the City of San Luis deserves a full time Magistrate.

Council Member Tadeo Azael De La Hoya asked if under this contract, will Judge Guerrero be able to perform all the duties and move the docket as dictated by the calendar and courts and not by the City Council.

Ms. Macuil responded she does not really practice in that court, so she cannot say for sure, but she hears from the Prosecutor that it is busy for it. Judge Guerrero has expressed that he would have a way of managing it.

Mayor Nieves Riedel said that in other occasions, Judge Guerrero has covered the Municipal Court as the City of San Luis hired him. She added Judge Guerrero spoke to her and he will not let the City of San Luis down. She indicated the court needs a judge with experience in managing the court. The city has had full time judges and never managed the court. The city advertised for the position of Magistrate and the city has received three (3) applications from out of town, in one (1) month.

Council Member Matias Rosales stated that the directive two (2) weeks ago was to advertise the position and the city has already received three (3) applications which is good, but it is too soon to find an applicant. He believes the city needs a full time judge and it is not a good idea to split it up between two (2) communities.

Vice Mayor Luis E. Cabrera stated it would be great to have Judge Guerrero in the city supporting the court but does not think it would be best to have him as a full time Magistrate. Per his conversation with the City Attorney and Assistant City Attorney, Arizona laws allows the city to have an assistant or a Special City Magistrate on an hourly basis and does not prevent the city to continue hiring a full time City Magistrate. It does not award him of a full time position to Judge Guerrero but does give him the position to support the city and be compensated for the time he is serving the City of San Luis residents.

Ms. Macuil added that it would have to be brought back as a separate item under the Supreme Court regulations, staff would have to prepare an ordinance that would give the power to the City Council upon approval to create a Special Magistrate and then they would have be appointed for two (2) years which will also include the process.

Council Member Gloria Torres commented that this contact will be for two (2) years and asked what will happen with the position that is open for a full-time judge.

Council Member Tadeo Azael De La Hoya mentioned that this is to approve a contract and to serve the residents.

Mayor Nieves Riedel stated that the only reason Judge Guerrero is considering this is because she asked him for help. If the City Council is worried that they will be stuck with Judge Guerrero for two (2) years, she can ask him to resign and he will. It is not just going in and hearing cases but also what is going on at the court.

Council Member Matias Rosales asked if the Superior Court has not assigned a Pro-Tem or have they moved the dockets.

Ms. Macuil responded at the time the position became open, they did not have any Pro-Tems. Therefore, the city has hired a Pro-Tem, the presiding judge order staff to do a contract. Currently, there is a Pro-Tem in place under the direction of the Presiding Judge.

Mayor Nieves Riedel added that it costs the city \$550.00 daily for the Pro-Tem.

Council Member Maria Cecilia Cruz commented they understand the importance of having its own judge, but she believes this is not enough time and agrees with Council Member Matias Rosales on the three (3) applicants. The opportunity is not being given to somebody who can serve the City of San Luis and this is what happens when the position is not filled.

7. C. Discussion and possible action on any and all matters regarding Ordinance No. 436. An ordinance of the Mayor and City Council of the City of San Luis, Arizona, amending and restating the San Luis City Code § 5.05.090 (B) and adding § 5.05.090(C) on Garage Sale business regulation, removing the yearly limitation; repealing any conflicting provisions; providing for severability; and imposing a penalty. (Kay Marion Macuil, City Attorney)

Ms. Kay Macuil, City Attorney, explained that this ordinance removes the four (4) yearly restriction on yard sales. She further explained that a residential location may conduct a garage sale from one (1) day up to four (4) days in a week; Thursday, Friday, Saturday and Sunday. Garage sales are prohibited on Mondays, Tuesdays and Wednesdays. Garage sales at a residential must be registered with the city under the city's codes. Registration is valid until the end of the calendar year, expiring on December 31st, no matter the time of the year the resident registers. Garage sales under the City Code are for the occasional sales of used or unwanted items not for retail sales, business or home occupations. Those wishing to create a business or home occupations must comply with the Zoning Code Regulations and apply for a business license.

There was some discussion between Council Members and staff in regards to number of permits during the year, days, items, city enforcement, manpower, process of applications for garage sales, defining garage sales and recommendation from staff.

7.D. Discussion and possible action on any and all matters regarding the purchase of two (2) Huber fine screens, for the East Wastewater Treatment Plant Improvements. (Manuel Hernandez, Public Works Project Manager)

Mr. Manuel Hernandez, Public Works Project Manager, stated that the Department of Public Works and its Wastewater division is seeking Council approval for the purchase of two (2) Huber fine screens. The fine screens are large pieces of equipment that will be needed for the upcoming improvement project at the East Wastewater Treatment Plant. Screens are used in wastewater treatment to remove large solid particles and other materials that may create operational maintenance problems in the treatment system. The two (2) screens have a lead time of 30-40 weeks or approximately ten (10) months. The screens need to be ordered this month in order to align with the improvement project construction schedule.

7. E. Discussion and possible action on any and all matters regarding the purchase of a new ambulance. (Angel Ramirez, Fire Chief)

Mr. Angel Ramirez, Fire Chief, explained that approximately two (2) months ago, the city had an ambulance that was involved in a collision on the way to the hospital in Somerton. This put a burden to the City of San Luis Fire Department budget wise as staff was going to put in for the purchase of another ambulance next fiscal year. The insurance adjusters came in and as of now they do not have a timeframe as to when the wrecked ambulance will be back in service; it was not totaled but had severe damage. This puts back down up to having one (1) backup ambulance. Staff met with City Administration and the Finance Department to discuss the purchase of a new ambulance. Staff contacted the vendor, Custom Ambulances, and it is taking them approximately 30 months from the time of purchase to delivery. There was a demo one that a municipality failed through, so they staff to inform them it was available. Staff has looked into the specifications and it is what the City of San Luis Fire Department needs. It is a 3500 model, usually staff purchases 4500 models, but it is a 4x4. This ambulance will be ready and available hopefully at the beginning of June 2023. Mr. Ramirez asked the Mayor and City Council for authorization to purchase an ambulance this fiscal year to have coverage. If authorized, the purchase will be made through the Houston Gavelston Area Council Agreement in the amount of \$228,900.00.

Vice Mayor Luis E. Cabrera commented that when there is an accident and it takes time to get the wrecked vehicle operable, the insurances provide a rental car. In this case, the insurance might not provide an ambulance but can surely contribute towards the purchase of the expense.

Ms. Monica Castro, Director of Finance, indicated that the purchase can be made as it is a necessity and look into the matter to check for additional funding negotiation from the insurance towards this purchase.




