Mayor Nieves Riedel acknowledged Mr. Manuel Figueroa, former Municipal Magistrate for the City of Somerton, presence.

Mr. Christian Espinoza, 1021 N. Beach Street, San Luis, AZ, commented that he is there on behalf of his neighborhood due to the notice of traffic control change and the idea of modifying the way traffic flows in that area. He added that most residents in that neighborhood are upset about this change and unfortunately were not able to be present due to medical conditions. Most of his neighbors are of the third age and a few times they have had situations where the ambulance has been called and they have a certain route they come this neighborhood through. With this new change, they are now forced to put someone else's life on the line regarding something that was never broken but yet the city is trying to fix. With the flow of traffic that the city is putting on to them, it will increase the stress in seconds. It does not make sense to re-route something that has perfectly worked.

Ms. Ofelia, 1048 N. Beach Street, San Luis, AZ, proposed that the street be widened to implement the traffic control change in her neighborhood.

7. DISCUSSION AND POSSIBLE ACTION ITEMS:

7. A. Discussion and possible action on any and all matters regarding consulting services to conduct a Base Compensation Study. (Adela Cortez, Director of Human Resources)

Ms. Adela Cortez, Director of Human Resources, explained that staff is seeking approval for a transfer of funds to be able to conduct a base compensation study for employees. The last study was conducted in 2018 and during these five (5) years some positions have been studied, but it is necessary to perform a full review of all classifications. Research of vendors was conducted and three (3) responded. The vendor that provided the best proposal in terms of time frame and cost is Public Sector Personnel Consultants. This item was not budgeted in the General Fund and has been reviewed with the Finance Department and there is money allocated in a different fund that are not going to be used that could be transferred.

Cabrera to approve the transfer of funds in the amount of \$33,000.00 from money budgeted for a potential Community Development Block Grant, which was not awarded to San Luis this year, to the Human Resources Department Contractual Services Account to pay for a base compensation study. 7. B. Discussion and possible action on any and all matters regarding authorization for employees' Cost of Living Adjustment (COLA) for FY 2023-2024. (Roula Encinas, Finance Operations Manager)

Ms. Roula Encina, Finance Operations Manager, stated that at the beginning of the year, the city provided salary adjustments for all employees. The city could not bring all employees to their target salary based on budget constraints. In addition, the wages targeted do not reflect the current market and the unprecedented inflation being faced. The salary study staff implemented is dated from 2018, and the minimum wage has increased every year.

Moreover, the minimum salary will increase by 3.5% in January 2024, creating a salary compression issue in the salary structure of the city. To address this issue, a new base compensation study will be conducted. Unfortunately, these types of studies take time to complete and implement. In the meantime, the city is struggling with retention and hiring due to competitive pay.

For these reasons, to provide an incentive for employees and bring them closer to what the real market is, staff is recommending a one (1) time COLA adjustment of \$1,000.00 for full-time employees and \$500.00 for part-time employees so that the employees can take home close to \$720.00 for full-time employees and \$420.00 for part-time employees, after payroll deductions. A mid-salary budget review was performed, concluding that there is budget capacity due to vacancies that staff has been unable to fill. Staff is requesting for the City Council to approve the salary re-classification to the different departments that were approved on July 2023, at the beginning of the fiscal year and to approve a one (1) time COLA adjustment.

Council Member Tadeo Azael De La Hoya asked if the city could give the employees the full amount, the \$1,000.00 and \$500.00 and take care of the payroll deductions through their W2's?

Ms. Encinas responded that staff would need to increase the amount and the taxes are different for each employee and cannot estimate how much each employee is paying on the taxes and another salary analysis will need to be conducted. The estimated current salary analysis for the one (1) time COLA adjustment is \$310,000.00 plus benefits.

7. C. Discussion and possible action on any and all matters regarding the acceptance and award of a construction contract to Continental Flooring Company for the Cesar Chavez Cultural Center Floor Replacement Project. (Edgar Juarez, Facilities Project Coordinator)

Mr. Edgar Juarez, Facilities Project Coordinator, mentioned that the Division of Facilities is seeking Council approval for accepting and awarding a construction contract to Continental Flooring Company, for the Cultural Center Floor Replacement Project. Continental Flooring Company ranked highest in accordance with the Request for Proposal Documents, and they submitted the most responsible bid.

The project consists of removing existing flooring, surface preparation, and installation of new vinyl composite tile (VCT) in the Cesar Chavez Cultural Center in the following areas: auditorium, audio room, lobby, hallway, offices and the janitorial room. In addition, stage flooring will be replaced by hardwood flooring. The Cultural Center is in need of floor replacement since the current floor has deteriorated over time and has served its life expectancy. It will have a five-year warranty and with its proper maintenance, it should last another 15-20 years.

The Facilities Division is seeking Council approval of Construction Services from Continental Flooring Company and the contract for this project for the amount of \$69,764.00 as permitted under the city's procurement code section 3.05.030 Bidding.

During the holidays the facility will be closed and the project will take place. The different activities will be relocated to a different facility in the meantime.

7. D. Discussion and possible action on any and all matters regarding the removal of the appointed directors to the Greater Yuma Port Authority and the appointment of replacement directors. (Jenny Torres, Acting City Manager)

Ms. Jenny Torres, Acting City Manager, explained that the City of San Luis appoints two (2) potential representatives to the Greater Yuma Port Authority (GYPA). Council Member Matias Rosales has served two (2) terms and Mr. Frank Rascon has been there for eight (8) years. He has served and represented the city for many years. Council Member Matias Rosales' term will end in December 2024. Staff is recommending having another elected official serve on the Board of GYPA for continuity and succession planning. Mayor Nieves Riedel has agreed to serve on the Board of GYPA if the City Council so desires.

Mayor Nieves Riedel commented that Council Member Matias Rosales will run for a position at state level and she will be privileged to shadow Council Member Matias Rosales.

7. E. Discussion and possible action on any and all matters regarding authorizing outside counsel to initiate litigation regarding a solid waste truck that the city purchased but has not been in working order. (Kay Marion Macuil, City Attorney)

Ms. Kay Macuil, City Attorney, stated that there is a trash truck the city purchased and it did not make through an entire route before there were problems with the lift. The company did not do what it should have to take care of the situation, therefore it was submitted to an attorney and at this point the attorney would like to proceed to litigation. This vehicle was nearly half a million dollars.

Council Member Tadeo Azael De La Hoya asked if the company is refusing to fix it or are they being unresponsive or what is the reason to hire a \$375.00 an hour attorney?

Mr. Manuel Hernandez, Acting Assistant Director of Public Works, responded that the Dennis Eagle Spartan side loader solid waste truck began to have problems when staff first received it, it ran less than a nine (9) hour route and could not complete an entire route. It has been in and out of repairs, and the Public Works Department does not feel confident that this is a good company to work with, therefore staff has asked the Legal Department to support them with litigation. When the truck was delivered to the city, it was sent back almost immediately, then they sent it back to the city. The truck tried to run for an entire route and did not work and was sent back; the vendor has had it longer than the city has had it for. Finally, they dropped it off in the middle of the night, threw the keys at one of the employees and said it was a delivery. Staff has tried to work with the vendor, but it has not been successful. The truck was left there as advised by the Legal Department.

Ms. Macuil added that a demand letter was mailed to the vendor via certified mail, without any response, there are emails and proof of phone calls as well. The outside attorney's costs will not probably go over \$40,000.00 and has not billed the city yet.

Mayor Nieves Riedel commented that the city should also go after attorneys' fees as the residents have paid the price as they are paying for the service.

Cabrera/Council Member Javier Vargas to authorize William Richardson, under the terms of his engagement letter, to represent and defend the City of San Luis, its officials and employees and prosecute any and all claims, counterclaims, or third-party complaints against any person or entity that owe either a duty or damages to the City of San Luis arising out of the purchase or repairs to the 2021 Dennis Eagle Proview Solid Waste Truck describe in this agenda item. The motion passed with six (6) ayes and one (1) nay vote by Council Member Tadeo Azael De La Hoya.

Council Member Matias Rosales asked what is the reason the in-house Counsel is not doing this?

Ms. Macuil responded that in-house work is quite intense and she needs an assistant, she has not been able to hire one. Mr. Glenn Gimbut, Assistant City Attorney, is going down on his hours and is not able to keep on top of a litigation file.

7. F. Discussion and possible action on any and all matters regarding a contract for prosecutor services through an independent contractor. (Kay Marion Macuil, City Attorney)

Ms. Kay Macuil, City Attorney, explained that Ms. Heather Vinci, a local attorney, has been covering the prosecutor's position since September. She has been doing excellent work and has been able to keep on top of the heavy case load. She requested a transfer of budget from the prosecutor's salary line to contractual service to fund this contract. The city is looking for a prosecutor, one (1) response was received and will interview the applicant

7. G. Discussion and possible action on any and all matters regarding the City of San Luis awarding the bid to GCI Construction & Inspection, L.L.C., for the fabrication and installation of automatic swing entrance gates at the City of San Luis Public Works Yard and the East Wastewater Treatment Plant. (Manuel Hernandez, Acting Assistant Director of Public Works)

Mr. Manuel Hernandez, Acting Assistant Director of Public Works, said that staff is seeking the approval to award the bid to GCI Construction and Inspection for the fabrication of automatic swing entrance gates at the 4th Avenue Public Works Yard and the East Wastewater Treatment Plant. This is the second time Public Works has bid on this project where only one (1) bid was received in October 2023; unfortunately, this bid was disqualified because it was turned in late. The formal bid held November 14, 2023, resulted in much lower bid results of potentially saving the City of San Luis over \$65,000.00. A total of four (4) bids were received where GCI Construction and Inspection was the lowest responsible bidder in the amount of \$84,200.00. GCI Construction and Inspection has been in business for over ten (10) years and are currently working on a large contract in the Tucson area with Veil Unified School District.

7. H. Discussion and possible action on any and all matters regarding the purchase of four (4) Aurora model 4x5x10B split case booster pumps for the water department. (Jorge Perez, Assistant Director of Public Works)

Mr. Jorge Perez, Assistant Director of Public Works, stated that the City of San Luis water system is composed of a series of wells and filtration system units, distribution lines and booster pumps. The use of the booster pumps is to bring the water from the well sites to the homes, businesses and any facilities that receive the services. This is a budgeted item for Fiscal Year 2024 and is being procured through a sole source vendor, who is JCH, as permitted per City Code Section 3.05.020 – Exclusive Services.

7. I. Discussion and possible action on any and all matters regarding the City of San Luis accepting slurry seal application services from American Pavement Preservation for the application of Type 2 slurry seal as part of the 2023 Pavement Preservation Project. (Jorge Perez, Assistant Director of Public Works)

Mr. Jorge Perez, Assistant Director of Public Works, indicated that the Public Works Department was granted \$100,000.00 for budget purposes for this program. The city did some striping spending approximately \$8,000.00 from those funds. The city followed a procurement process by piggy backing on the City of Yuma's contract with American Paving for slurry application. Staff has identified some sections that are in need of slurry application with an estimated cost of \$90,000.00. He asked for a purchase approval and ratification of Purchase Order No. 2021-1574 in the amount of \$90,000.00

Most of the expense is from GSA and the city is doing small stuff like sidewalk ramps, curb relocation, a waterline as part of the improvements that the city would have to do.
