A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, INCREASING BUSINESS LICENSE FEES AND ADOPTING NEW BUSINESS TYPES; REPEALING ANY CONFLICTING PROVISIONS; AND PROVIDING FOR SEVERABILITY.

WHEREAS, on April 27, 2005 the City, via Resolution No. 600, established the business license fee schedule for various vocations; and

WHEREAS, the City of San Luis is desirous of establishing a new business license fee schedule and adopting new business types therein; and

WHEREAS, in accordance with A.R.S. § 9-499.15, the City Council convened on November 12, 2025, at which any member of the public was provided proper notice and privileged to appear and be heard in favor or against any proposed business license fees.

NOW THEREFORE BE IT RESOLVED by the Mayor and City Council of the City of San Luis, Arizona as follows:
