AN ORDER OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAN LUIS, ARIZONA, AUTHORIZING AND DIRECTING THE CITY OF SAN LUIS POLICE DEPARTMENT TO RECEIVE FUNDING FOR HOURLY PAY AND EMPLOYEE RELATED EXPENSES BY APPROVING AND AUTHORIZING THE EXECUTION OF AN INTERGOVERNMENTAL AGREEMENT WITH GADSDEN ELEMENTARY SCHOOL DISTRICT #32 AND THE CITY OF SAN LUIS, ARIZONA, THROUGH THE SAN LUIS POLICE DEPARTMENT FOR TWO (2) SCHOOL RESOURCE OFFICERS.

WHEREAS, the City of San Luis desires to increase police presence within the San Luis Middle School and Southwest Junior High School grounds through the assignment of School Resource Officers, which brings a broader awareness of the school's safety needs and concerns while given the assigned officers greater experience working a school environment; and

WHEREAS, the Gadsden Elementary School District #32 has approved an Intergovernmental Agreement to enhance school safety and education throughout San Luis Middle School and Southwest Junior High School; and

WHEREAS, the Gadsden Elementary School District #32 has prepared an Intergovernmental Agreement which provides for all the funds including that these funds shall not be used to supplant other funding of the San Luis Police Department no related to this IGA; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of San Luis, Arizona, as follows:

SECTION 1: That it is deemed in the best interest of City of San Luis and its residents that an Intergovernmental Agreement titled "SCHOOL RESOURCE OFFICER BETWEEN THE CITY OF SAN LUIS AND GESD #32." is approved.

SECTION 2: That a true copy of said Intergovernmental Agreement is incorporated herein as Exhibit "A" as though fully set forth again in full.

SECTION 3: That the Mayor or City Manager and/or his designee are hereby authorized and directed to execute this Intergovernmental Agreement on behalf of the City of San Luis and to take any and all actions as may be necessary to put the agreement into effect.

SECTION 4: That the San Luis City Clerk and/or her designee is authorized and directed to maintain this Intergovernmental Agreement in the official files of the City Clerk and to deliver it to Yuma County, Arizona.
