

ORDER OF GENERAL/SPECIAL ELECTION

An election is hereby ordered to be held on the 5th day of November, 2024, in Webb County, Texas, for the purpose of electing the following county and precinct officers as required by Article XVI, Section 65 of the Texas Constitution:
