CALL TO ORDER BY THE HONORABLE TANO E. TIJERINA, WEBB COUNTY JUDGE

1. Roll Call by Honorable Margie Ramirez-Ibarra, Webb County Clerk
2. Pledge of Allegiance/Invocation
3. Discussion and possible action for Approval of Bills, Payroll, and Monthly Reports (Treasurer, Human Resources, Risk Management; and any other Department reports); and any other matters incident thereto.
4. Public Comment - This section provides the public the opportunity to address the Commissioners Court on any items on the Agenda. Members of the public wishing to participate must complete a Witness Card specifying which agenda item they wish to comment on. Each public member, individually or in a group, will be allowed a total of Three (3) minutes within which to make any/all public comments.

COURT TO DISCUSS AND ACT ON THE FOLLOWING:

CONSENT AGENDA: At most meetings, the Commissioners Court establishes a Consent Agenda. It consists of those Agenda Items which are routine or non-controversial, and which neither a member of the Commissioners court has asked to be pulled for discussion. Once the Commissioners Court has established the Consent Agenda, Agenda Items included on it will be voted upon in one vote, and will not be discussed separately unless requested by the County Judge or Commissioners.

The consent agenda has been created in order to give constituents the opportunity to view any and all pertinent backup information with reference to any item in the agenda. The objective of the consent agenda is for all Webb County constituents to be familiar with everyday county business and to demonstrate the transparency and fairness of this Commissioners Court.

The following Agenda Items are of a routine nature, and the Commissioners Court has received supporting materials for consideration. All of these Agenda Items will be passed with one vote without being discussed separately, unless a member of the Commissioners Court or the public requests that a particular Agenda Item be discussed. If so, that Agenda Item will be pulled from the Consent Agenda and discussed as part of the regular Agenda at the appropriate time. One vote will approve the remaining items on the Consent Agenda.

CONSENT ITEMS

5. Auditor

- a. Discussion and possible action to authorize a one (1) year Software as a Service (SaaS) Financial Reporting service agreement with Gravity IGM Technology Corp. for an amount not to exceed \$34,500.00 (\$19,500 annual service fee plus \$15,000 implementation fee) and any other matters incident thereto. **[Account #1001-1260-001-443000-110 (Repairs & Maintenance-Software)]**

Issue: With new financial reporting requirements as set by the Governmental Accounting Standard Board (GASB) for local governments, implementation of the proposed cloud-based software will assist the County Auditor with the annual financial reporting requirements.

Solution: Consider the approval of the proposal as recommended by the County Auditor. The Purchasing Agent advertised and secured three (3) proposals in response to public solicitation request. Gravity IGM Technology Corp. is the best price, designed in compliance with GASB 34 and Government Finance Officers Association reporting requirements and is a cloud-based software that meets the expectations for annual financial reporting requirements by the County Auditor.

Result: Approve the proposal submitted by Gravity IGM Technology Corp. for a one (1) year cloud-based software agreement as presented in order to prepare the County's Annual Comprehensive Financial Report.

- b. Discussion and possible action to ratify the transfers from General Fund to the Webb County Fairgrounds Special Revenue Fund for \$515,997 and the Casa Blanca Golf Course Fund for \$777,216 for the year end encumbrances for capital expenditures.

Issue: The Webb County Fairgrounds Special Revenue Fund and the Casa Blanca Golf Course Enterprise Fund encumbrances for capital expenditures have not be completed as of September 30, 2024.

Solution: The Commissioners Court has already allocated funding for transfers during fiscal year 2024 and the County Auditor is respectfully requesting to transfers the balances for next year to make the available funding for next year for completing the capital expenditures.

Result: The Webb County Fairground Special Revenue Fund and the Casa Blanca Golf Course Enterprise Fund will have the available funding for the capital expenditures for next year.

6. Civil Legal Division

- a. Discussion and possible action to enter into a Non-Financial Professional Services Agreement between Webb County, for the Webb County Early Child Headstart Care Partnership (EHS-CCP), and Serving Children and Adults in Need (S.C.A.N.) for substance abuse education for the Webb County Early Child Headstart Care Partnership (EHS-CCP) for use in their early head start programs. This agreement establishes the terms and conditions under which S.C.A.N. will be providing their professional substance abuse education programs to the Webb County Head Start (EHS-CCP). This agreement shall be for a three year (3yr.) term for three scholastic calendar years commencing September 1, 2024, through August 31, 2027, and authorizing the County Judge to sign and execute all relevant documents, and any other matters incident thereto. **[Requested by Aliza Oliveros, Director, Webb County Head Start (Funding Source-Non-Financial Agreement)]**

7. Honorable Victor Villarreal, County Court at Law 2 Judge

- a. Discussion and possible action to approve a 12-month agreement (effective October 1, 2023 to September 30, 2024) between Webb County for the benefit of the Webb County Court-at-Law II DWI Court Program and Serving Children and Adults in Need (SCAN, inc) in the amount not to exceed two hundred twenty thousand dollars (\$220,000.00). SCAN, inc will provide substance abuse and treatment counseling for DWI Court participants as listed and approved on the grant application through U. S. Department of Health & Human Services SAMHSA and authorize the Webb County Judge to sign all relevant documents and any other matters incident thereto. **[Account #2356-2070-003-457008-025]**

Issue: Webb County Court-at-Law II DWI Court services DWI Offenders in Webb County.

Solution: Effectively service area offenders through substance abuse counseling, mental health and other resources provided by the court with SCAN, inc partnership.

Result: Obtaining the services by SCAN, inc is a key component of grant requirements.

- b. Discussion and possible action to approve a 12-month agreement (effective October 1, 2023 to September 30, 2024) between Webb County for the benefit of the Webb County Court-at-Law II DWI Court Program and Amistad Consultation and Evaluation Services in the amount not to exceed Nine thousand dollars (\$9,000.00). Dr. Todd Russell and Drew Russell will service the DWI Court Program team to have access to professional evaluation of the court and consulting; as listed and approved on the grant application through U. S. Department Health & Human Services SAMHSA and authorize the Webb County Judge to sign all relevant documents and any other matters incident thereto. **[Account #2356-2070-003-432001]**

Issue: Webb County Court-at-Law II operates The DWI Court program.

Solution: Evaluation and Consulting services will assist DWI Court team monitor grant compliance.

Result: Obtaining the services by Amistad Consulting and Evaluation Services is a key component of grant requirements.

8. **District Attorney**

- a. Discussion and possible action to continue paying grant-funded personnel under OCDETF for work performed until notification and allocation of funds by the grant award from the U.S. Department of Justice Drug Enforcement Administration. All personnel costs will be reimbursed with grant funds. **[Fund #2587-2260-001-413000]**

Issue: Current grant funding expired on September 30, 2024. The D.A.'s Office has not received notice of award for the new grant. Unless this item is approved, personnel working under this grant will not be paid after September 30, 2024.

Solution: Grant a payroll extension effective October 1, 2024.

Result: The Webb County District Attorney's Office will continue to employ the grant-funded personnel, and will continue to execute its duties against criminal activity.

- b. Discussion and possible action to authorize the transfer of unit 56-05 - 2018 Chevrolet Silverado VIN: 3GCUKREC6JG483171 from the 406th District Court to the Webb County District Attorney's Office and any other matters incident thereto. **[Account #1001-2270-001-443000-075 (General Fund-County Attorney-Administration-Repairs & Maintenance-Vehicles)]**

Issue: The District Attorney's Office is in need of vehicles due to several of their units having mechanical issues.

Solution: Consider to authorize the approval to transfer county owned unit no longer being used by the 406th Judicial District Court to the District Attorney's Office for official use.

Result: Fixed asset records will reflect the assignment to the Webb County District Attorney's Office. Department currently has both fuel and maintenance accounts to cover related expenses for their fleet.

- c. Discussion and possible action to approve a reimbursement agreement between Webb County for the benefit of the District Attorney's Office and the Organized Crime Drug Enforcement Task Forces program (OCDETF) for an amount not to exceed \$181,443. The total reimbursable amount covers overtime for investigators assigned to the DEA Task Force (\$145,443.00) and payments related to 3 leased vehicles (\$36,000). The period of performance for this agreement is October 1, 2024, through September 30, 2025. Forfeiture funds will be utilized to cover the fringe benefits allocated to the overtime therefore no impact to the General Fund. **[Account #2587-2260-001-413000]**

Issue: Collaboration between Federal, State and local law enforcement agencies is necessary to pursue and dismantle organized crime organizations along Webb County and the Texas Border.

Solution: Accept Federal assistance to continue local participation in Joint Operations under the Organized Crime Drug Enforcement Task Forces Program.

Result: Disruption of organized criminal activity along the Texas border and in Webb County.

9. **Commissioners Court**

- a. Discussion and possible action to authorize the County Judge to issue a letter of concurrence to the Foreign-Trade Zones Board, U.S. Dept. of Commerce in support of establishing a usage driven FTZ designation (Minor Boundary Modification), City of Laredo Foreign Trade Zone (F.T.Z.) - a. Discussion and possible action to approve the posting and filling of the following (grant-funded) Slot, subject to the availability of payroll funds and any applicable Civil Service guidelines, effective October 15, 2024:

Issue: The employee in this position was promoted to a full-time slot on September 16, 2024.

Solution: We propose advertise and hire a replacement for this position. The new hire will play a crucial role in delivering healthy hot meals to eligible elderly in our community.

Result: This action will ensure the continued provisions of hot, nutritious meals to seniors through the Meals-on-Wheels and Elderly Nutrition Program.

- b. Discussion and possible action to authorize the Webb County Community Action Agency to enter into a vendor agreement with Retail Energy provider (listed below) for the implementation of the Community Services Block Grant (CSBG) and the Comprehensive Energy Assistance Program (CEAP). This vendor agreement is a Texas Department of Housing and Community Affairs (TDHCA) requirement for the implementation of the programs, authorizing the County Judge to sign all relevant documents and any other matters incident thereto. This agreement shall be effective from the 1st day of January 2025 for a period not to exceed two years from the effective date. **[Account #2362-5360-521-463804 (Comprehensive Energy Assistance Program)]**

Retail Energy Provider:

Gexa Energy

Issue: This vendor agreement is a Texas Department of Housing and Community Affairs (TDHCA) requirement.

Solution: The Webb County CAA will enter into a two-year vendor agreement with Gexa Energy Provider for the implementation of the Community Services Block Grant (CSBG) and the Comprehensive Energy Assistance Program (CEAP).

Result: The Texas Department of Housing and Community Affairs (TDHCA) will provide funding to be used for payment of qualifying low-income clients' home energy expenses.

- c. Discussion and possible action to approve a nine-month contract agreement between Webb County Community Action Agency (WCCAA) and the Texas Department of Housing and Community Affairs (TDHCA) for the Community Services Block Grant (CSBG) Program State Discretionary Funds - Organizational Capacity Improvements (OCI) for PY-2024. CSBG-D Contract No. 61240004328 shall commence on August 01, 2024, and, unless earlier terminated, shall end on May 31, 2025, in the amount of One Thousand, Four Hundred Twenty-Eight Dollars (\$1,428.00); and authorizing the County Judge to sign all relevant documents. This action will not have an impact to the General Fund. Documentation has been reviewed by Webb County Economic Development Department and is compliant with SPOC policies and procedures.

Issue: Community Services Block Grant requires entities to complete an Organizational Standards report every year.

Solution: Accept a Grant State Discretionary Funds to procure a consultant to develop an Organizational Standards report.

Result: The support services are intended for Organizational Capacity Improvements (OCI) to assist with meeting Organizational Standards.

- d. Discussion and possible action to approve the acceptance of Amendment #3 to Contract #61240004152 for the Community Service Block Grant (CSBG) from the Texas Department of Housing and Community Affairs (TDHCA) for program year 2024. This amendment is a grant increase in the amount of Sixty-Five Thousand Two-Hundred Ten Dollars (\$65,210.00). This action will not have an impact to the County General Fund. Documentation has been reviewed by Webb County Economic Development Department and is compliant with SPOC policies and procedures. **[Account #2368-5170-330300 (Grant Revenue)]**

Issue: TDHCA has awarded CAA a grant increase under the CSBG Program in the amount of \$65,210.00.

Solution: The Court approval of CSBG Amendment #3 will benefit both operations and administrative expenses.

Result: Webb County CAA Social Services will continue to provide direct services to eligible low-income residents of Webb County under the CSBG Program.

- e. Discussion and possible action to enter into a one (1) year (September 24, 2024 through September 23, 2025) "Client Tracking Management Software System" Agreement for the Community Action Agency's Social Service Program to CAP Systems, Inc. at a one-time cost of Nineteen Thousand Dollars (\$19,000.00) for the Software Licenses and Training plus a monthly support and maintenance fee of the software in the amount of One Thousand Five Hundred Dollars (\$1,500.00) (annually \$18,000.00) for a total cost of Twenty-Seven Thousand Dollars (\$27,000.00), and authorizing the Webb County Judge to execute all relevant documents; and any other matters incident thereto.
[Account #2368-5170-521-457008 (Contractual); Account #2362-5360-521-457900 (Program Services Expenditures)]

Issue: The current agreement with Client Management Tracking Provider has expired. The Community Action Agency is required to solicit proposals to continue tracking clients through a software system and enter into a contract to continue said client tracking services.

Solution: At its commissioners' court meeting of August 26, 2024, the Court awarded Request for Proposal (RFP) 2024-010 "Client Tracking Management Software" to CAP Systems, Inc.

Result: Approving a contract with CAP Systems, Inc. will allow the Community Action Agency Social Services Program to continue to collect, track, manage and/or store their client data information as needed in order to meet mandated eligibility and/or reporting requirements of the Texas Department of Housing and Community Service Block Grant ("CSBG") and Comprehensive Energy Assistance Program (CEA). Subject to Budget Appropriations, the Agreement provides for the Agreement to be extended for an additional three (3) one-year periods.

12. Drug Court Program

- a. Discussion and possible action to modify the Job Title, adjust pay, and filling of the following grant-funded Slot, subject to the availability of payroll grant funds and any applicable Civil Service guidelines, effective October 15, 2024:

Issue: The previous approved item included level I and level II counseling positions for the Drug Court. Both Counselors will have the same requirements, duties and responsibilities.

Solution: Amend the title to state Drug Court Counselor I and adjust salary to reflect \$65,000.

Result: Changes to the job title and pay will allow us to fill the position and provide adequate treatment services to the program without further interruption.

- b. Discussion and possible action to authorize the following change in job title/job description for slot #3019 (grant-funded) subject to the availability of payroll funds and any applicable Civil Service Guidelines for the Veterans Treatment Program:

Issue: Current Job title and description does not properly describe the day-to-day duties and responsibilities of the Assistant Case Manager.

Solution: The reclassification of slot #3019 will accurately reflect the correct duties and responsibilities of the position.

Result: Changes will reflect the required duties and responsibilities the job entails.

13. Economic Development

- a. Discussion and possible action to accept a grant award for the Violent Crimes Against Women Criminal Justice and Training (VAWA) from the Criminal Justice Division (CJD) Office of Governor (OOG) in the amount of \$7,000.00 grant funds for training and supplies for investigators and patrol officers working at the Webb County Sheriff's Office serving victims of violent crimes against women and authorize Webb County Judge to sign all relevant documentation. This grant requires a \$3,000 cash match; This \$3,000 cash match will be met by the Webb County Sheriff's Office forfeiture funds. Thus, this grant will have no impact on the general fund. All required documents were reviewed by the Economic Development Department and the solicitation is compliant with the Webb County Single Point of Contact (SPOC) procedures. **[Account #2152-3010-001 (Forfeiture Funds)]**

Issue: Violence against women is among the most intractable and deadliest criminal justice problems in the United States, especially domestic violence and in the South Texas area. According to published statistics, the number of American women between 2001-2012 who were murdered by current or ex-male partners in the United States was 11,766. That's almost double the amount of casualties lost during wars in Afghanistan and Iraq. Women who will be victims of severe violence by an intimate partner in their lifetimes number 1 in 4. ("30 Shocking Domestic Violence Statistics That Remind Us It's An Epidemic" Vagianos 10/23/2014).

Solution: Grant award to enhance the tools, techniques, and training to those investigators who follow-up to calls for assistance, conduct interviews with these victims, file incident reports, provide these victims with information/referrals to service providers, initiate arrests of perpetrators, refer cases for prosecution, and prepare testimony/evidence for trial in cases of domestic violence, sexual assault, dating violence, and stalking.

Result: Enhanced law enforcement services, including investigative techniques, to deal with emergent criminal trends, such as cyberstalking, and improved efficacy of the law enforcement response to the needs of victims of violent crime.

- b. Discussion and possible action to enter into an Agreement for an amount of Twenty One Thousand Seven Hundred Forty Dollars and Fifty Cents (\$21,740.50) with the United States Department of Justice, Drug Enforcement Agency and Webb County for the benefit of the Webb County Sheriff's Office for the performance period of (October 1, 2024–September 30, 2025, being FY 2025), said agreement (Operation "Steady Moving") will provide funding needed for task force duties and overtime reimbursement payments to Webb County and the Webb County Sheriffs' Office will cover and estimated Six Thousand Dollars (\$6,000) in fringe benefits from its State Forfeiture Account; and authorizing the Webb County Judge to sign all relevant documents and any other matters incident. **[Requested by the Webb County Sheriff's Office, Fund #2600-3010-001-413000 and Fringes Fund #2150]**

- c. Discussion and possible action to accept a grant award in the amount of \$31,193.82 (OAG Contract No. C-01832) for the Fiscal Year (FY) 2025 Statewide Automated Victim Notification Service (SAVNS) from the Office of the Texas Attorney General (OAG) for the automated notification of crime victims for a period of Twelve (12) months beginning on September 1, 2024, through August 31, 2025, and authorizing the Webb County Judge to execute all relevant documents; and any other matters incident thereto. There is no cash match, and, thus, there is no impact on the general fund. All required documents were sent for review through the Economic Development Department and the solicitation is compliant with the Webb County Single Point of Contact (SPOC) procedures. **[Requested by the Webb County Sheriff's Office, Fund #2712-3010-443000-035]**

Issue: In the past decades, many crime victims, such as victims of sexual assault and domestic violence, were unaware if their respective crime perpetrators were able to post bail and be released from the correction's system. In late 1993, one particular victim who had been raped, assaulted, and stalked in Jefferson County was unaware that her former boyfriend had been released and was subsequently ambushed by him after she left work. She was shot seven (7) times at point-blank range and killed on that day, her 21st birthday.

Solution: As a result of community outrage, an automated telephone notification system for crime victims and other concerned citizens was instituted: Victim Information and Notification Every day (VINE) Service. This nationwide system is funded by Texas counties through the Texas Office of the Attorney General (OAG) and is currently utilized by Webb County.

Result: The crime victims of Laredo/Webb County can enroll in this program and will be provided with automated notification upon an offender's custody status change, such as release, transfer, and/or relevant district court dates.

- d. Discussion and possible action to accept award and enter into an agreement with the Texas Comptroller and accept the award in the amount of \$275,000 through the Rural Prosecutor's Office Salary Assistance Grant. All required documents were sent for review through Economic Development Department and the solicitation is compliant with the Webb County Single Point of Contact (SPOC) procedures. This grant does not require a cash match. There will be no impact to the County's General Fund. **[Requested by Isidro "Chilo" Alaniz, District Attorney]**

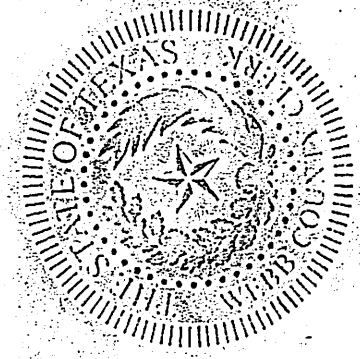

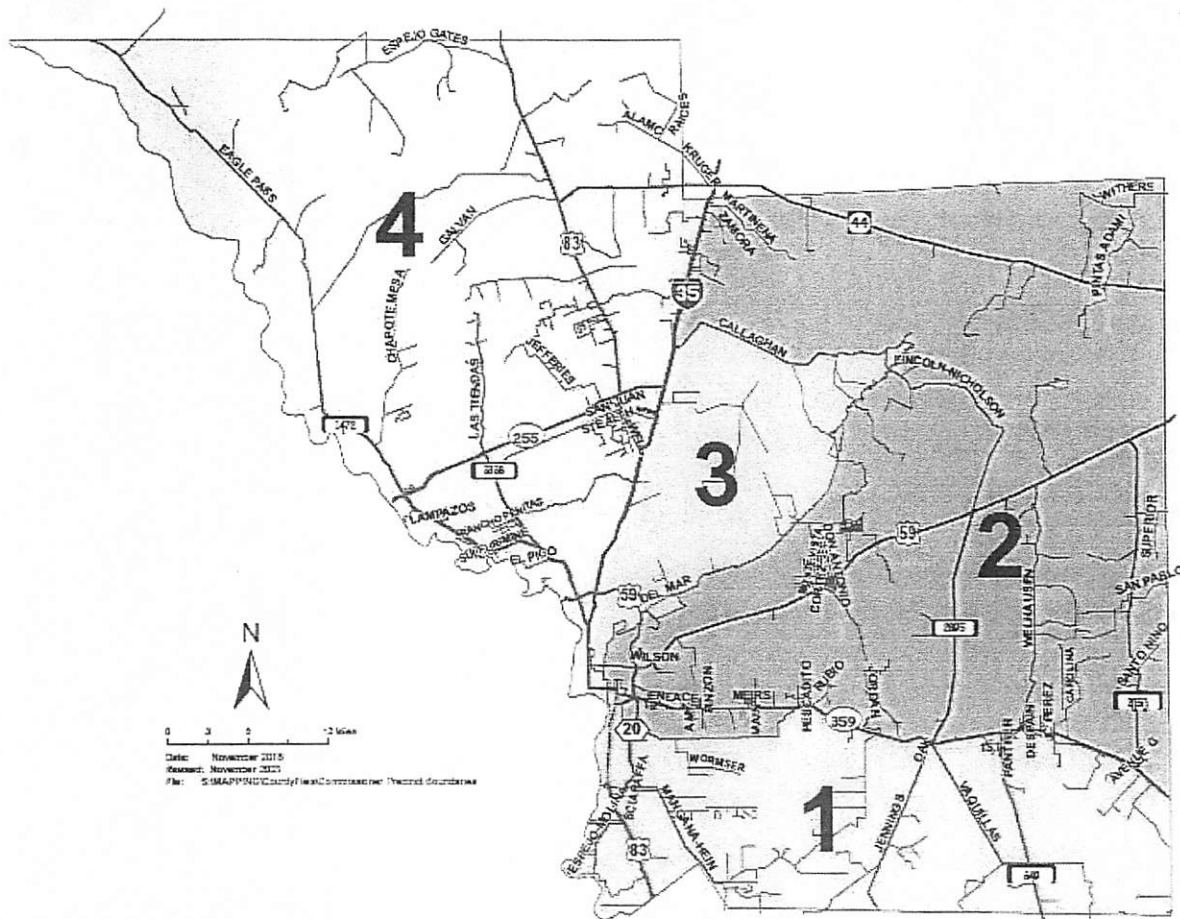
