

**A RESOLUTION OF THE COMMISSIONERS COURT OF WEBB COUNTY, TEXAS,
AUTHORIZING THE SUBMISSION OF A TRANSPORTATION ALTERNATIVES
SET-ASIDE (TA) PROGRAM APPLICATION TO THE TEXAS DEPARTMENT OF
TRANSPORTATION AND AUTHORIZING THE WEBB COUNTY JUDGE TO ACT AS
THE COUNTY'S EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN
ALL MATTERS PERTAINING TO THE COUNTY'S PARTICIPATION IN THE
TEXAS DEPARTMENT OF TRANSPORTATION; AND AUTHORIZING THE
COUNTY JUDGE TO EXECUTE ANY AND ALL RELEVANT DOCUMENTS AND
ANY OTHER MATTERS INCIDENT THERETO.**

WHEREAS, the Texas Department of Transportation issued a call for projects in January 2025 for communities to apply for funding assistance through the Transportation Alternatives Set-Aside (TA) Program; and

WHEREAS, the TA funds may be used for development of preliminary engineering (plans, specifications, and estimates and environmental documentation) and construction of pedestrian and/or bicycle infrastructure. The TA funds require a local match, comprised of cash or Transportation Development Credits (TDCs), if eligible. The Webb County would be responsible for all non-reimbursable costs and 100% of overruns, if any, for TA funds; and

WHEREAS, the TA funds may be used for construction of pedestrian and/or bicycle infrastructure for the cities of El Cenizo and Bruni. The TA funds require a 20% approximate (\$120,000) local match for Bruni, which will be covered by TDCs. The Webb County would be responsible for all non-reimbursable costs and 100% of overruns, if any, for TA funds; and

**NOW, THEREFORE, BE IT RESOLVED BY THE WEBB COUNTY
COMMISSIONERS COURT OF WEBB COUNTY THAT:**

The Webb County supports funding this project(s) as described in the 2025 TA Detailed Application (including the preliminary engineering budget, if any, construction budget, the department's direct state cost for oversight, and the required local match, if any) and is willing to commit to the project's development, implementation, construction, maintenance, management, and financing. The Webb County is willing and able to enter into an agreement with the department by resolution or ordinance, should the project be selected for funding.

1. That a Texas Department of Transportation (TxDOT) application for the Transportation Alternatives Set-Aside (TA) Program is hereby authorized to be filed on behalf of the County with the Texas Department of Transportation.
2. That the County's application be placed in competition for funding under the Transportation Alternatives.
3. That the application being applied for by Webb County is for up to \$600,000.00 of grant funds to provide construction of pedestrian and/or bicycle infrastructure in the TA program funding.

4. That the Commissioners Court directs and designates the following to act in all matters in connection with this application and the County's participation in the Transportation Alternatives Set-Aside (TA) Program as follows:
- a) The Webb County Judge shall serve as the County's Chief Executive Officer and Authorized Representative to execute this application and any subsequent contractual documents;
 - b) The Webb County Judge and County Commissioner for Precincts 1 and 2 are authorized to execute environmental review documents between the TA and Webb County; and
 - c) If this application is funded, the Webb County Judge and County Commissioner for Precincts 1 and 2 are authorized to execute the Request for Payment Form documents and/or other forms required for requesting funds to reimburse project costs.
 - d) That all funds will be used in accordance with all applicable federal, state, local, and programmatic requirements, including but not limited to procurement, environmental review, labor standards, real property acquisition, and civil rights requirements.
