Note: Bid Item #18 on the bid tabulation was not applied on site; the associated funds were instead allocated to additional concrete riprap.

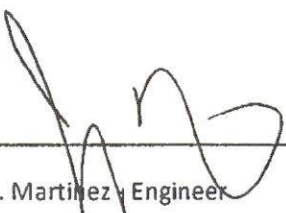

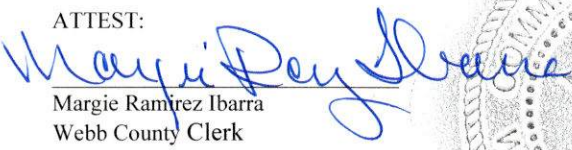
