**AGREEMENT BETWEEN WEBB COUNTY AND ORION HEALTHCARE TECHNOLOGY,
FOR AN EXTENSION OF THE CURRENT AGREEMENT GRANT RENEWAL
6H79TI081929-05M001**

The original Agreement, dated May 31, 2024 by and between **WEBB COUNTY**, a political subdivision of the State of Texas (hereinafter called "County") for the benefit of the Webb County Veterans Treatment Program and Orion Healthcare Technology. (Hereinafter called "Accucare"), is hereby amended as set forth below:

Paragraph 1: The original agreement contained a performance date of May 31, 2023 to May 30, 2024 and the parties to said agreement have conferred and agreed to extend the agreement to 29 day of September 2024.

Paragraph 2: The original price was set in the Agreement that is attached hereto as EX A and both parties have agreed to the price increase for the extended period of time in Paragraph 1 above.

Paragraph 3: The parties agree that the foregoing amendment shall be hereinafter considered a part of the contract referred to above and incorporated by reference therein for all purposes. The amendments shall be subject to any and all other provisions of the contract which are hereby ratified by the parties and remain in full force and effect, with the exception of the parts or provisions of the contract which have been modified by this amendment or prior amendments.

Paragraph 4: The parties agree that the foregoing amendment requires additional consideration for services. The additional funding shall run with the original agreement attached hereto in the amount not to exceed amount quoted in Attachment B for FY 2023-2024 of service ending September 29, 2024.

This Agreement becomes effective when signed by the last party whose signing makes the Agreement fully executed.

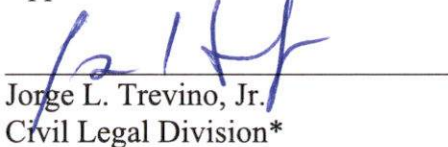

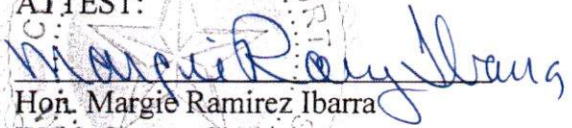

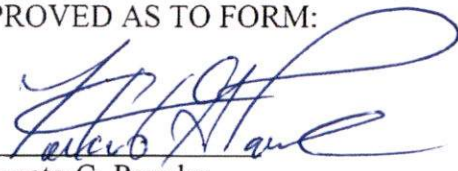
