**RESOLUTION NO. 09-09-2024-28
WEBB COUNTY COMMISSIONERS COURT**

A RESOLUTION APPROVING AN ADVANCE FUNDING AGREEMENT BETWEEN WEBB COUNTY AND THE TEXAS DEPARTMENT OF TRANSPORTATION FOR MANGANA HEIN ROADWAY SHARED USE PATH SEGMENT 2 PROJECT (CSJ: 0922-33-228) AND AUTHORIZING THE COUNTY JUDGE TO SIGN ANY NECESSARY DOCUMENTS THAT MAY BE NEEDED BY THE TEXAS DEPARTMENT OF TRANSPORTATION.

WHEREAS: Webb County is in the process of entering into an Advance Funding Agreement with the Texas Department of Transportation (TxDOT) for Construction and Construction Engineering, Right-of- Way, and Inspection for the Magana Hein Shared Use Path Segment 2 Project; and

WHEREAS: Webb County desires to authorize the Webb County Judge to execute an Advance Funding Agreement for the Magana Hein Shared Use Path Segment 2 Project; and

WHEREAS: this Advance Funding Agreement will authorize the use of Carbon Reduction Program (Category 10) funds for the above-mentioned tasks for the Magana Hein Shared Use Path Segment 2 Project; and

WHEREAS: the Carbon Reduction Program (Category 10) funds require a local match, Webb County desires to provide this match. Webb County will be responsible for all non-reimbursable costs and 100% of overruns, if any.

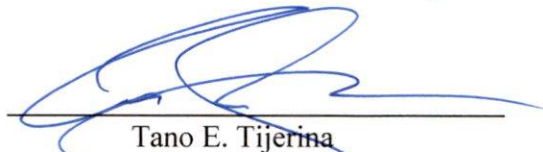
NOW, THEREFORE, BE IT RESOLVED BY THE WEBB COUNTY COMMISSIONERS COURT THAT:

Section 1: Webb County approves entering into an Advance Funding Agreement with the Texas Department of Transportation where the County will be responsible for the local match contribution (estimated at \$968,820.00) and for all non-reimbursable costs and 100% of overruns, if any; and

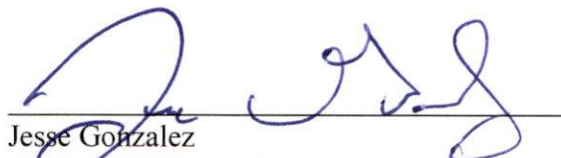

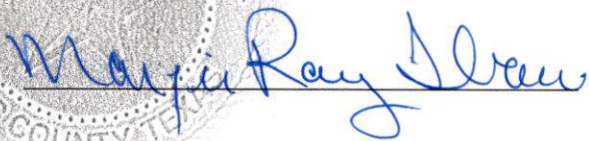
