

RENEWAL 2025-2026

[RENEWAL OF CHILDPLUS SOFTWARE SERVICE AGREEMENT 11/1/2024-10/31/2025]

The original Agreement, commencing November 1, 2024 to October 31, 2025, by and between **WEBB COUNTY**, a political subdivision of the State of Texas (hereinafter called "County") for the benefit of the Head Start Program and Management Information Technology USA, Inc. d/b/a ChildPlus® Software (hereinafter "ChildPlus"), is hereby amended and renewed as set forth below:

1. The County exercises its right to renew the Agreement (Attached hereto as Exhibit A) between the parties for another term in accordance with:
 - a. Section 12.1 which provides, "At the end of the initial term, Services may be renewed at the Customer's option, for successive one (1)-year terms beginning upon the completion of the previous term, by notifying ChildPlus of Customer's intention to renew and paying all Fees for the renewal term."
2. The parties agree that the foregoing renewal shall be hereinafter considered a part of the contract referred to above and incorporated by reference herein for all purposes. The new term shall be subject to any and all other provisions of the contract which are hereby ratified by the parties and remain in full force and effect, with the exception of the parts or provisions of the contract which have been modified by this amendment or prior amendments.
3. The parties agree that the foregoing amendment requires additional consideration for services for the renewal term. The additional funding shall equal **\$41,574.10** for the additional services provided beginning November 1, 2025, with a termination date of October 31, 2026.

This Agreement becomes effective when the original term ends and continues services for the renewal period.

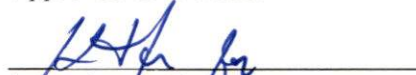
