A RESOLUTION APPROVING AMENDMENT NO. 1 TO THE ADVANCE FUNDING AGREEMENT BETWEEN WEBB COUNTY AND THE TEXAS DEPARTMENT OF TRANSPORTATION FOR THE MANGANA HEIN ROADWAY EXPANSION PROJECT SEGMENT 2 (CSJ: 0922-33-232) AND AUTHORIZING THE COUNTY JUDGE TO SIGN ANY NECESSARY DOCUMENTS THAT MAY BE NEEDED BY THE TEXAS DEPARTMENT OF TRANSPORTATION.

WHEREAS: Webb County previously executed an Advance Funding Agreement with the Texas Department of Transportation (TxDOT) for Construction and Construction Engineering, Right-of- Way, and Inspection for the Mangana Hein Roadway Expansion Segment 2 Project; and

WHEREAS: Webb County desires to authorize the Webb County Judge to execute an Amendment No 1 to the Advance Funding Agreement for the Mangana Hein Roadway Expansion Segment 2 Project adding additional Category 12 Strategic Partnership funds for construction; and

WHEREAS: this Advance Funding Agreement will authorize the use of Surface Transportation Program Metropolitan Mobility Rehabilitation (Category 7) and Strategic Partnership (Category 12) funds for the above-mentioned tasks for the Mangana Hein Roadway Expansion Segment 2 Project; and

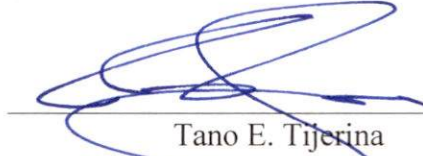
WHEREAS: the Category 7 funds require a local match, Webb County desires to provide this match. Webb County will be responsible for all non-reimbursable costs and 100% of overruns, if any.

NOW, THEREFORE, BE IT RESOLVED BY THE WEBB COUNTY COMMISSIONERS COURT THAT:

Section 1: Webb County approves Amendment No. 1 to the Advance Funding Agreement with the Texas Department of Transportation where the County will be responsible for the local match contribution for all non-reimbursable costs and 100% of overruns, if any; and

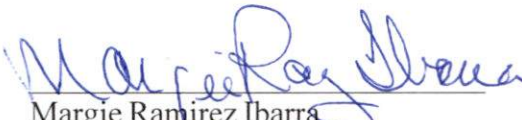
Section 2: The Commissioners Court directs that this Resolution be included with the Advance Funding Agreement (AFA ID Z00009787); approves the Advance Funding Agreement and authorizes the County Judge to execute said Advance Funding Agreement and any other documents required by TxDOT.
