Re: Pre-Qualified Engineers List for Re-Certification

---

Williamson County has gone through a procurement process to pre-qualify engineering firms for the next round of projects funded through the FY 2006 Road Bond Program. Forty-nine (49) engineering firms and/or teams responded to RFQ# 08WCRFQ804. One (1) firm, Fugro Consultants, Inc., is not included in this pre-certification for engineering design work because they submitted for a different type of engineering work not included in this request for qualifications.

A review team consisting of Joe England, Richard Ridings and myself have reviewed the submittals. We are recommending that the firms be pre-qualified in two groupings. The groupings are based on the size of the road projects as it relates to the estimated construction costs and the complexity of the proposed improvements especially TxDOT projects.

The components of the project affect the resources (quantity, type and location) that a firm has to address unique/complex issues, as well as to complete the project in a timely manner. Any firm qualified to do a large complex project would also be qualified to work on small road bond project as well.
