We are planning a Block Party for our street, Box Canyon Terrace and a small portion of 2 adjoining streets, Fern Bluff Ave. and Park Valley. The location where we would like to have the party, is on a portion of Park Valley between Fern Bluff Ave. and Box Canyon. There are 3 driveways that enter onto this portion of Park Valley but we would only be interfering with 1 driveway and the owner of that home has given us permission to block it for the evening, her address is 17865 Park Valley Drive, Round Rock, 78681.
