THIS GRANT STATEMENT is entered into and forms a part of that certain Grant Agreement dated <u>December 15, 2010</u> (the "<u>Agreement</u>") by and between PetSmart Charities, Inc. Grant Terms		
<b>Effective Date:</b>	<u>December 15, 2010</u>	
<b>Grant Funds:</b>	\$48,000 for the Grant Purpose as stated below.	
Grant Conditions:	Prior to PetSmart Charities' distribution of the Second Installment of Grant Funds, the Organization must satisfy the following conditions (the "Grant Conditions"), as determined by PetSmart Charities in its sole and absolute discretion:  The Organization must have completed approximately 650 of the spay/neuter surgeries described in the Grant Purpose.	

<b>Grant Distributions:</b>	PetSmart Charities will distribute the Grant Funds to the Organization for the Grant Purpose as follows:	
	□ First Installment: \$24,000.	
	□ Second Installment: Approximately 12 months after the First Installment is paid, \$24,000.	
<b>Grant Purpose:</b>	The Grant Funds will total \$48,000 over two years. The Grant Funds will be used by the Organization solely for the purpose of:	
	□ Focus of surgeries: Approximately 1,300 spay/neuter surgeries on free-roaming cats located in Cedar Park, Leander and Liberty Hill, Texas.	
	☐ In the first 12 months of the Grant Period, completing approximately 650 spay/neuter surgeries, with:	
	o \$22,750 for the cost of surgeries, including rabies vaccinations, at an average of \$35 per.	
	o \$1,250 for outreach materials and advertising.	
	☐ In the second 12 months of the Grant Period, completing approximately 650 spay/neuter surgeries, with:	
	o \$22,750 for the cost of surgeries, including rabies vaccinations, at an average of \$35 per.	
	o \$1,250 for outreach materials and advertising.	
Grant Period:	The Grant Period will commence on the Effective Date set forth in this Grant Statement, which in no event shall be earlier than effective date of the Agreement and will continue for a period of <u>24 Months</u> .	

Reporting Obligations:	In addition to any requirement set forth in the Grant Agreement, the Organization agrees to provide the following reports to PetSmart Charities in connection with this Grant Statement, on or before the deadlines set forth below. PetSmart Charities reserves the right to change the method and format of how reports are provided.

	☐ A budget for the project's second year.
	For non-governmental organizations: (1) The Organization's updated audit, if the Organization's income for the fiscal year was equal to or greater than \$500,000. (2) The Organization's updated IRS Form 990. (3) If the report is due prior to an updated audit and/or IRS Form 990 being completed: (a) the Organization's unaudited actual statement of activities (income and expenses) and balance sheet for that fiscal year; and (b) a statement as to when the audit and/or IRS Form 990 will be sent to PetSmart Charities.
