Dear Mr. Johnson:

A review of the referenced project/tract has been completed in accordance with the Williamson County Regional Habitat Conservation Plan (RHCP). Based on the supporting documents provided on your behalf by Kristy L. Knaupp-Beyer, Senior Staff Environmental Scientist, Natural Resources, Terracon, 5307 Industrial Oaks Boulevard, Austin, Texas 78735, Inc., the Williamson County Conservation Foundation (WCCF) makes the following determination as to your application:

- 1. The mitigation fee for the referenced project will be \$38,605 (Thirty-eight Thousand Six Hundred Five Dollars and no hundredths Dollars). This amount ("Participation Fee") was determined based on the acreage of the tract, a determination no geologic or manmade karst features and 3.64 acres of good quality Golden-cheeked Warbler (Setophaga chrysopari) habitat and 3.75 acres of secondary habitat with mitigation values of \$7000/acre and \$3500/acre respectively. (A map outlining the referenced tracts is attached to this letter.) This amount will be reflected in Paragraph 2 of the Participation Agreement ("Agreement") to be issued as outlined below.

An agenda item will be prepared for the next available Williamson County Commissioner's Court for consideration and acceptance.
