Univar was unresponsive - did not submit transmittal letter nor sign conflict of interest questionnaire

John Deer Landscapes was unresponsive - took exception to Wilco's terms and conditions by changing section 2.2.14 Indemnification; Williamson County opted not to accept the changes made to the terms and conditions by John Deer Landscapes;

Crop Production Services was low bid on items# 2, 6&7. Winfield Solutions was low bid on item# 1&8 however failed to submit all required documentation by deadline. Therefore these items will be awarded to Crop Production Services for convenience.

Item 3 & 4 Winfield Solutions, Red River Specialties and Crop Production Services bid the same pricing.

Item 5 Red River Specialties and Crop Production Services bid the same pricing. It is the recommendation to award items 3, 4 & 5 to Crop Production Services referring to the Local Government Code Section 271.905 Consideration of Location of Bidder's principal place of business. Crop Production Services' principal place of business is in Taylor, Texas. Awarding these items to this company will contribute to the economic development of Williamson County.
