## QUESTIONS/CLARIFICATIONS FOR DUNBAR COURIER BID AUGUST 31, 2015

1. The address for the Central Texas Treatment Center, with one stop per week on Wednesday, is:

601 N Alligator Rd

PO Box 488

Granger, TX 76530

The Cost for this location being out of service area will be \$50 a stop.

2. The stop at the Southwest Regional Park, Leander should be changed to **one day** per week, day to be determined. Please explain the route which makes this stop 20 minutes round trip off route.

Because of routing and services planed for your company this account is being serviced by routes by Dunbar. The closest route that will service this location will be 20 min round trip.

## 3. PRICING DATA SHEET:

**No more than \$25,000 in cash per location per day**: During the tax season (December and January), there may be days where that amount is exceeded due to residents paying their property taxes in cash. This will be rare, but may occur. The maximum should be well under \$50,000 on those rare occasions.

We will be changing the liabilities to \$50,000 for all locations, this will not change pricing.

Dunbar's pricing assumes no more than five items at each location: Williamson County cannot operate under this limitation. During the Courier stop yesterday I realized that we keep a copy of the number of items picked up each day (somewhat haphazardly in a file). I took the opportunity to review several months of activity. While many of the locations will only have 2-3 items, two locations have numerous offices dropping deposits into the safe room vault: WC Justice Center at 405 MLK Blvd and the Sheriff's Office at 508 Rock Street (next door). Items numbered up to 7 items routinely, with occasionally up to 9 and at times, up to 12. HOWEVER, the items are limited to



two types of cash bags: Clear, which go to the Wells Fargo Cash Vault and White, which come to the Treasurer's Office. All are scannable, and while not bulky to handle, we do understand the time involved to scan and account for each Red Book.

We will be changing your bag limit to 15 for these two locations. Keep in mind we charge for bag pickup not drop off for services.

We request that your pricing be such that there are no limitations with regard to number of items. We will not take advantage of unlimited pickups, but we must know, for budgetary purposes, what our monthly costs will consistently be.

The budget will remain the same please refer to the answer above.

4. Dunbar will pick up most of the County's locations before 3:00 PM: The time offered for pickup/delivery to the Treasurer's Office at 710 Main Street, Georgetown should be the last stop of the day, not between 0800 - 1200. There will be 10 – 20 white cash bags (fairly light, not bulky) that will be picked up from the various Williamson County stops for subsequent delivery to the Treasurer's Office. These will be counted and consolidated into one deposit for pickup by the Courier the following day.

These bags will be consolidated overnight in our vault and delivered the next day to the treasures office. These bags might be 1-5 bags a location are not counted as item bags when consolidated to a drop off location. We only count for pickup not drop off.

## Additional Requirements:

- 5. The Courier who is awarded this contract will guarantee, barring any unforeseen difficulties, that delivery of deposits to the Wells Fargo Cash Vault in Austin will be next day by 3:00 PM. Due to unforeseen circumstances, "Acts of God" we cannot guarantee delivery next day. We have priced services to deliver next day to the WFCV and considering it is down the street from us this should not be a problem.
- 6. The Courier who is awarded this contract will provide information regarding the pickup of change orders from the Wells Fargo Austin Cash Vault. Currently, if the cash is ordered via the Cash Vault by 10:30 AM, it is delivered the next day. Can Dunbar meet this schedule? Yes a change order sheet will also be available for deliveries that can be emailed or faxed to any one location for authentication.

7. It would appear, based on the Trip Charge, that Dunbar will charge based on the number of days service for the month. Our current Courier Service charges a per month fee, regardless of days. That would be the preference if Dunbar would consider a monthly charge rather than a Trip Charge, again, for budgetary purposes.

For billing we will be providing a monthly charge. For days for pickup can be changed given a weeks notice.

However, if Dunbar chooses to stay with a Trip Charge system, how much advance notice (in hours) must the County give Dunbar if County Offices are closed due to bad weather? It is presumed that the County would give Dunbar a listing of Holidays and that would suffice for regularly scheduled closures.

Due to "Acts of God" locations that are closed clients will be contacted by our branches that will not be serviced. A holiday service schedule is on the first page of our Redbooks that will be provided to ever location. This Redbook is used to keep a written documentation of all pickups of deposits. The number for the branch that is servicing the location is also on the first page as well.
