Dear County Judge and Commissioners,

Recently our county Sheriff's Office made a request for qualifying the sole source purchase of a MINI Z Backscatter X-Ray Imaging System, manufactured by American Science and Engineering Inc. and distributed by Dailey-Wells Communications. Dailey-Wells Communications is the only authorized reseller to represent and sell AS&E equipment in our region. Procurement of this system must be purchased exclusively from Dailey-Wells Communications.

After reviewing all documentation requested and submitted by the Sheriff's Office, I recommend qualifying this request as a sole source purchase per Texas Local Government Code sections 262.003 (a) and 262.024 (a) (7).

The process has included the following:

- Public posting of an RFI in BidSync for 14 days, with no responses received
- A signed Sole Source Justification Request submitted by Lt. Tony Carter
- A signed letter of justification from the supplier, establishing why they their product / service is only available from their company; as well as responses to additional questions asked
- A notarized Sole Source Affidavit completed by the supplier
- A signed letter of recommendation from L.C. Marshall, Chief Deputy
- An invoice from the Daily-Wells Communications in the amount of \$48,975.00 for the MINI Z
 Backscatter X-Ray Imaging System.
- A notarized Certificate of Interested Parties (Form 1295) as required by the Texas Ethics Commission

Additional justification information requested from American Science and Engineering for qualification as a Sole Source provider

- 1. Although Dailey-Wells Communication Inc, located in San Antonio, is the only authorized reseller of this product in Texas; are we required to buy exclusively from this dealer, or can we buy from any other AS&E dealer in the USA?
 - Dailey Wells is the only authorized reseller to represent and sell AS&E equipment in your region. All system procurement must be purchased exclusively via Dailey Wells.
- Do other dealers offer EXACTLY the same pricing and structure, or might they offer a different price for the EXACLTY same item?
 All dealers follow AS&E pricing requirements for our products. We've established a standard price for

domestic sales via our distribution network, all regional dealers follow the same pricing structure.

- 3. Although your technology has been stated as the only scanner of this type available, if we advertise for alternative competitive solutions, what would you expect as the result?
 The Mini Z system is the only hand held Backscatter X-ray on the market. Competitive X-rays are
 Transmission based, which require higher X-ray energy, a detector to be set up to capture the X-ray scan, and due to the X-ray source power, are not hand held. Other technologies that may be used in this market would not provide a scan image for interpretation (trace detectors, busters, etc.)
- 4. What differentiates your product from other openly available X-Ray systems?

 The MiNi Z system's Z Backscatter technology enables real-time, single-sided imaging in a small form factor for unsurpassed operational flexibility—scanning in tight confines where other systems can't scan.
