Following is a summary of the bid totals:

The Contractor's low bid is \$234,201.44 below the Engineer's Estimate, a cost saving of 5.8%.

The lowest four bids are within 10% of each other, representing extremely competitive bidding. In addition to meeting the bid qualifications subject to being low bidder, Cox Commercial Construction has performed similar work and received positive recommendations from the seven references contacted. Based on the references provided by the Contractor, we concur with the recommendation of the design engineer, K Friese & Associates, for award of the Bill Pickett Trail contract to Cox Commercial Construction in the contract amount of \$3,806,133.30.
