Dear Ms. Hancock,

Please find attached the bid tabulations for the subject-referenced project. The bids have been reviewed for correctness, with Patin Construction being the low bidder. The bid proposals for the project included alternate bids for a 12 inch and 16 inch City of Round Rock waterline. After comparison of the bids to the project budget, the City determined that Alternate #1 would be implemented. Following is a summary of the bid totals:

The Contractor's low base bid plus Alternate #1 is \$2,037,381.95 below the Engineer's Estimate, a cost saving of over 38%.

In addition to meeting the bid qualifications subject to being low bidder, Patin Construction has performed similar work on other projects on the Williamson County Road Bond Program, successfully completing CR 174 at Brushy Creek and CR 260/266 intersection improvements. We recommend award of the Arterial H Extension construction contract to Patin Construction in the contract amount of \$3,210,934.80.
